

John Lawrence (LA) reported on COTA. The Children's Organ Transplant Association (COTA) is the premier organization providing fundraising assistance to transplant families. COTA is a 501(c)3 nonprofit organization, so funds raised to help meet transplant expenses are not considered income for families. COTA also works with individuals of any age with single-gene disorders such as Polycystic Kidney Disease, Cystic Fibrosis or Sickle Cell Disease. COTA's services and guidance are provided at no charge to transplant families. 100% of each contribution made to COTA in honor of patients helps meet transplant-related expenses, and gifts to COTA are tax deductible to the fullest extent of the law. COTA funds can be used for transplant-related expenses that include lodging, transportation, household expenses, prescription medications, insurance premiums, living donor costs and much more. John also provided the 2021 financials for COTA.

Chris Sherman (WI) reported that he is still working with the 128th Air Refueling Wing of the National Guard for our C&Y Academy at National Convention. As of Friday April 29, 2022, word was received from the 128th Command staff that we will be notified by next Thursday May 5, 2022 if we can hold this event at their facilities. Chris will keep the Committee informed of their decision. He does have a plan B in place if not accepted. Our Legion family will be contacted to see if they would be interested in attending our academy.

Terry Harris (KS) gave his report. As an organization the Sons of The American Legion has crossed over the 9 million dollar amount in donations to CWF. We all need to pat each other on the back, enjoy the achievement, and then get back to work. Total CWF donations this year is \$349,577 from all of The American Legion family. The Sons have donated \$182,045 which represents 52% of all donations. The CWF booth at the National Convention will have many items for sale that also help with the fundraising. From shirts to emergency phone chargers, they always have a wide variety of CWF branded items.

Chairman Noble read John Mejia's (CA) submitted report as follows. Gentlemen, as April comes to a close we will be exiting Children and Youth month. Our goals for children and youth should be for every day of the year, with every squadron doing their utmost best to demonstrate what it means to be a member of our Sons of The American Legion. Our upcoming program of the Ten ideals should be the perfect tool for our youth to understand what it will take to be a future leader of the Sons.

We must cultivate and educate. Today's youth is tomorrow's veteran, yes we must remember our veterans and their children. We members of The American Legion family must provide, demonstrate and support activities for their children. Most military bases have a Family Readiness Officer (FRO) who would welcome our support for their military and children.

Chairman Jim Noble noted April is Children and Youth month. The following letter was forwarded out through the National Vice Commanders who then forwarded it out to the Detachments.

One of the four pillars of The American Legion is Children and Youth. Since 1938, the month of April has been designated as Children and Youth month. Take the time and support our children and youth. Joseph Navarrete - Americanism Chairman - Thanked everyone for the fundraising efforts for CWF.







Chairman Skelley (TX) noted one (1) correction: The West's Region Report on page 2 of the October 1, 2021, Minutes was given by NVC Stewart (NV) and National Membership Committee Member Jack Youngs (ID), **not** Matt Griffis (AZ). David Mennell (MI) made a motion to approve the October 1, 2021 Minutes with the noted correction. Ernie Laberge (MA) seconded the motion. Discussion – none. Hearing none, Chairman Skelley (TX) declared the minutes approved as corrected.

#### **Reports of Members:**

Chairman Thom Skelley: No formal report was filed.

#### East Region Reports

Chairman Ernie Laberge: Deferred to NVC Huntley.

NVC Dickie Huntley, Sr.: Stated that Chairman Laberge has done a fine job rallying membership in the East. The work has paid off this year and it has showed! Very rare to see the Eastern Region out in front on membership! Three (3) Detachments have already surpassed 100%. Ten (10) others are very close to 100%.

#### South Region Reports

Chairman Ron Roberts: Deferred to NVC Jason Roberts.

NVC Jason Roberts: Noted that if you look at the National SAL Membership Report, Puerto Rico has the highest percentage at 132%! NVC Roberts applauded Puerto Rico on a fine job! All the regions are in a very tight run! It is the hope that the South will be back on top by national convention. Much thanks to ALL the blue cappers!

#### **<u>Central Region Reports</u>**

Chairman David Mennel: Submitted a written report as attached.

NVC Jeff Vrabel, Sr.: Noted the most recent National SAL Membership Report that was published reflected that both the South and Central Regions were at an exact tie of 93.95%. A very singular occurrence!

#### **Midwest Region Reports**

Chairman Mike Kirschner: Submitted a written report as attached.

NVC Juan Torres: Deferred to Chairman Kirschner.

#### West Region Reports

Chairman Jack Youngs: Submitted a written report as attached. Jim Fisher (CA) was announced as Membership Chairman for the Western Region for the 2022-23 SAL administrative year.

NVC Jim Stewart: Deferred to Chairman Youngs.

#### **Old Business:**

Chairman Skelley (TX) announced the **Commander of the Year Award** that was accepted by the NEC and The American Legion will be presented at the 2022 National Convention. Due to the confidentiality of the award winner, the Membership Committee would enter Executive Session at the end of today's regular meeting. The members of the Committee would review the nominations and decide on the winner. In addition, the Committee would review the **Detachment Recruitment Award**, created via a resolution in 2019.

Marc Chaney (OR) questioned the status of the **proposed SAL Paid Up For Life (PUFL) program.** Chairman Skelley (TX) replied that further study was needed to determine its feasibility. However, very little input was received when recent inquires were sent out to the Detachments. So we need volunteers to step-up to help research and investigate such a program to determine if it could well in the SAL, perpetually. National Commander Fox (CA) is willing to appoint an ad hoc committee if enough volunteers express interest. Jeffrey M. Vrabel, Sr. (OH) volunteered to serve on the PUFL ad hoc committee, if created. Dennis K. Albright (OH) also volunteered to serve. Chairman Skelley (TX) stated volunteers should email him if they are interested to serve on a PUFL ad hoc committee.

Internal Affairs Chairman Bill Clancy, III (NY) offered general words of wisdom to the Membership Committee.

#### **Strategic Plan Priorities**

- Paid Up for Life Program; Chairman will follow up on this to see that we are moving forward and will be in contact with Committee members on his findings.
- Collection of email addresses: This is a work in progress.
- Annual Squadron Data Report: This needs to be filled out to enable legion.org to work for online renewals.

#### myLegion.org

- Online membership renewals
- Chairman Skelley (TX) reported that there has been written notice sent to The American Legion requesting "read only" access for Regional Chairmen and National Chairman to mylegion.org/Personify.

Annual Squadron Data Report dues details required for the Squadron to get their per capita back.

#### New Business:

Chairman Skelley (TX) discussed **Resolutions 7 and 8 listed below.** NVC Jeffrey M. Vrabel, Sr. (OH) drafted Resolution 8. It was in review by The American Legion, who is restructuring its Target Dates as well. If Resolution 8 is approved by the

SAL National Membership Committee at this meeting, it would then be presented to the SAL NEC for adoption this weekend. If that holds true, it is the opinion of The American Legion that it will hold Resolution 8 for further study.

Chairman Skelley (TX) opened the floor to discussion on Resolution 7. NVC Jeffrey M. Vrabel, Sr. (OH) suggested the charter revocation period for inactive squadrons begins after three (3) years of inactivity. However, the emphasis should always be revitalization. Remember, it is a lot harder to apply for a new charter than it is to reactivate a dormant squadron. Chairman Skelley (TX) agreed with NVC Richard "Dickie" Huntley, Sr. (ME) that the proceedings to revoke a squadron charter are left to the sponsoring Legion Post on a voluntary basis.

Jack Youngs (ID) noted that Posts can apply for war memorial grants and perhaps it could assist with the maintenance of a deteriorating Post in Maine that was mentioned by Chairman Skelley (TX). Gene H. Therox (MA) shared his experience with coordinating a community preservation project in conjunction with a Westfield, Massachusetts, Post.

NEC Camille A. LeJeune, Jr. (LA) received a list of inactive Louisiana squadrons from former SAL National Liaison Ken George back in November 2021. Camille worked that list and planned to return thirty-nine (39) SAL charters at the Spring 2022 NEC Meeting. Of those thirty-nine (39) charters, thirteen (13) had <u>not</u> appeared on Pico, where the Posts had already closed but the squadrons were still listed. So, there are some complications. Some of those Posts had not been active since the 1930s!

PNC Eugene Sacco (CA) remarked on inactive SAL charters. He inquired as to how many inactive charters are there nationwide. Chairman Skelley (TX) believed that Brian Compton had told him there are about 1,200 inactive charters across the nation. Raymond Jarvis (NY) noted there are about 300 inactive charters in the Detachment of New York. PNC Sacco questioned if there would be a process in place at National Headquarters to pull the known inactive squadrons after three (3) years. Chairman Skelley (TX) stated that some discussion has been had as to who that burden would fall on, however he did not think National would take on this responsibility. The Membership Committee had discussed this process before and the consensus was either the Department or Detachment Adjutant would lead this effort.

PNC Joe Mayne (MN) noted that National staff will take on the above referenced task if the SAL asks them to do it. PNC Sacco (CA) agreed and went on to elaborate that National now has two (2) staff members that are solely dedicated to SAL business. Therefore, we should utilize their resources. Chairman Skelley (TX) agreed and thanked the PNCs for their advice. Kevin Mook is the new National SAL Liaison (his sole responsibility is the SAL, dedicating his full attention to the program) and Brian Compton is Kevin's administrative assistant.

PNC Eugene Sacco (CA) noted that starting in the 2022-23 SAL administrative year, CENTCOM will advise ALL SAL commissions and committees to focus on just one (1) project within their respective commission or committee so that their particular project can be completed within 12 months. This will prevent stretching the SAL too thin in any given year.

Dennis K. Albright (OH) suggested that dialogue regrading inactive squadrons begin at the district levels. PNC Mayne (MN) could understand why a member from Ohio would suggest such a thing at the national level since Ohio has a very established structure. However, the challenge revealed from the recent reorganization of the SAL is that not many detachments can do what comrade Albright suggests. National will have to drive the message down to the squadron level.

Bill Kelly (FL) reported the Detachment of Florida had been scrubbing its squadron charters over the past few years. He explained the process they use to work in tandem with their department leadership to thin out inactive squadrons. Their review occurs every 3 to 4 years.

NEC Camille A. LeJeune, Jr. (LA) elaborated on the Detachment of Louisiana's approach to reviewing/reactivating inactive squadrons. He reiterated that Louisiana would be canceling 39 squadrons at the Spring 2022 NEC meeting. Chairman Skelley (TX) was saddened to learn such news but understood the need to cancel.

Jeff Van Horn (IL) went through the inactive squadrons list recently sent by National Headquarters. He noticed that some squadrons had been deactivated at the local level years ago but National had not processed the cancellations. Perhaps

National could do a better job of cleaning up that list so it reflects a more accurate status. Chairman Skelley (TX) reiterated that National will look into cleaning up the list now that the SAL has dedicated staff members.

Chairman Skelley (TX) challenged the meeting attendees to speak with their respective members about paying their dues in July each year, well before December. A few years back, the National Membership Committee proposed designating November has national renewal month, which falls in nicely with Veterans Day. What better way to honor your family member's military service on Veterans Day than to join/renew membership in the SAL. Chairman Skelley (TX) also went into the importance of renewals, and that as of April 2022 our renewal rate was 82%. He had concern as to the fate of the other 18%. Would those members come back, or had we lost them? It is imperative that phone calls be made to check-in on our members!

At this time, Chairman Skelley (TX) presented **2021 100% Blue Ribbons** to those Detachments that had achieved 100% membership by December 31, 2021. The honorees included: South Dakota, Hawaii, North Carolina, Philippines, South Carolina, Wisconsin, Idaho, Rhode Island, Iowa, Wyoming, Oklahoma, Arizona, Connecticut, and North Dakota.

The Membership Committee reviewed nominations for Squadron Commander of the Year and the Detachment Recruitment Award criteria.

How the tickets are distributed will be discussed later. With a brief discussion, the selection of Salmon will be the Fish preference available for the banquet.

A suggestion: the committee needs to check with the Legion about projected artwork on the ceiling and walls using the coin artwork. The discussion needs to involve what wee nee to provide for the filters and how many would be available for the banquet.

We are working on a list of names for Keynote speakers as suggested by Gene Sacco and Joe Mayne. The Bar for the Banquet will be a "No-Host" Bar (cash bar).

Vice Chairman Chuck Treat, II: Suggested the book prepress production staff be given latitude to use their talents to complete the layouts for a visually effective layout. Too many constraints will limit the opportunities for a visual pleasing project utilizing their talents.

David Faust: What do we have for table center pieces? Consideration in using the 50th coin as an art piece and follow-up with the hotel for coordinating those center pieces in the banquet set-up.

HIST Bill Towns, Jr.: A summary of where the 50<sup>th</sup> Commemorative book was on information gathering and preparation for the hand-off for layout and prepress proofs to be set. Detailed list of the annual artwork for each Convention lists two remaining convention year pins were missing for the years 2003 and 2008. Materials were being scanned and there is more to archive after the convention has concluded. This is important as we will need to start archiving our history before it is no longer available to us. We will be repeating this process in 5 to 10 years for the next benchmark. The Committee still has a few Past National commanders we need to have completed questionnaires returned. The closing efforts of the Committee needs to include archiving suggestions for the work product to date.

PNC David Faust: Discussed how the tickets would be "sold" and distributed for the dinner selections (meat, chicken or fish) and gave suggestions on the process for the banquet. Decision not final and suggestions would be offered at the next Committee Conference Call.


