First of all I want to congratulate Squadron 597 in Carrolton for reaching 100% plus 2 new members they are the 1st Squadron in our Division and also the Detachment to reach their goal of 100%. They will be receiving a \$50.00 check from Detachment for reaching goal before December 31 Deadline.

It's been 5 months now since you have had your election of officers in your Squadron. Certification of officers must be sent into Austin the day of or the day after the election to receive your new cards. As of last week every Squadron is certified.
