

# GRASSROOTS ALERT: TELL YOUR SENATORS TO SUPPORT THE STRONG VETERANS ACT

Our most sacred responsibility, as a nation and as veterans, is to care for our fellow men and women who have served this nation with honor. The American Legion has long had a "Buddy Check Week," asking our Legionnaires to conduct veteran outreach as part of their daily routine. The American Legion's "Buddy Check" program has been an excellent tool for membership, and we strongly support legislation that expands this program to VA.

"S.544 - the Buddy Check bill is now included as a provision in H.R. 6411 - the STRONG Veterans Act of 2022. This legislation is a comprehensive veterans' mental healthcare package that passed the House in July 2022. Amongst other provisions, it would:

- Expand eligibility for Vet Center services
- Require additional studies into veteran mental health research
- Mandate a review of the training for the Veterans Crisis Line responders
- Expand VA's Peer Specialist Support Program

It is now awaiting action in the Senate. The American Legion proudly supports this legislation and asks that you contact your Senators and tell them to support H.R. 6411 - the STRONG Veterans Act today!

#### **CONGRESS**

The new fiscal year starts next week, and Congress has yet to unveil continuing resolution (CR) language, much less vote on it. Next week, due to Rosh Hashanah (Jewish new year), both the House and the Senate will have only three legislative days to prevent a government shutdown on October 1. They do not currently plan to meet the first week in October, as Yom Kippur (Jewish Day of Atonement) falls on Wednesday.

Last week, negotiations appeared to be underway to have the CR go until mid-December. Some Republican lawmakers are now holding out for a January expiration date, which would allow them greater leeway in setting budget priorities should they gain the majority in either or both Chambers.

Sen. Manchin (D-WV) continues to insist on having his energy permitting language included in the CR. Congressional leaders seem optimistic that additional support for Ukraine will be included, although possibly not the full \$11.7 billion requested by the White House. With the recent hurricanes hitting Puerto Rico, some disaster aid may also be included.

The Administration has requested more money for COVID testing, vaccines, therapeutics, and the general public health response. However, President Biden's comments on 60 Minutes that the pandemic is over



combined with general Republican sentiment that enough money has been spent on that puts in doubt whether the CR will include this funding.

In several hearings this week, Pentagon officials informed lawmakers that ongoing recruiting efforts and sexual assault prevention reforms rely upon long-term, stable funding. One official suggested that Congress might consider providing two-year funding for recruiting to enable the Pentagon to purchase advance medial buys. Department of Veterans Affairs officials also told lawmakers that the electronic health record modernization (EHRM) project and other information technology programs are harmed by delayed budgets.

This week, Senate Majority Leader Schumer (D-NY) announced his Chamber will take up the FY23 National Defense Authorization Act (NDAA) in October. This announcement took many by surprise, as it was assumed lawmakers would stay home for October due to the looming elections.

# LEADER MCCARTHY & RANKING MEMBER BOST VETERANS ROUNDTABLE

On Tuesday, The American Legion participated in a Veteran Leadership Roundtable hosted by House Minority Leader McCarthy (R-CA) and House Veterans Affairs Committee Ranking Member Bost (R-IL). The roundtable brought Congressional leaders together with Veterans Service Organizations (VSOs) for a conversation about issues that America's veterans are currently facing.



The discussion focused on priorities for veterans and their families moving forward, including meeting the needs of veterans as they transition out of the military, improving care and benefits for veterans struggling with toxic exposure in light of the enactment of the Honoring Our PACT Act, and supporting veterans with mental health concerns. Other members of Congress present were Reps. Bergman (R-MI), Mann (R-KS), Moore (R-AL), Miller-Meeks (R-IA), and Ellzey (R-TX), all of whome presently serve on the House Veterans Affairs Committee (HVAC).

# SECRETARY MCDONOUGH TESTIFIES ON ACCESS TO CARE STANDARDS

### HOUSE VETERANS' AFFAIRS COMMITTEE PASSES SENDS 13 BILLS TO FULL HOUSE OF REPRESENTATIVES

On Wednesday, September 21, the House Committee on Veterans' Affairs (HVAC) held a full Committee markup, advancing 13 bills that will increase accessibility to mental health care and resources, promote equitable access to reproductive healthcare services for all veterans, and ensure that veterans transitioning from service to civilian life are fully and holistically supported and able to access comprehensive benefits.

### SENATE ARMED SERVICES COMMITTEE HOLDS HEARING ON MILITARY RECRUITMENT AND RETENTION

The Senate Armed Services Committee's Personnel Subcommittee met on Thursday, September 22, to discuss the status of military recruiting and retention efforts across the military.

All of the Military Services, both active duty and reserve components, face severe problems with recruiting. In its FY23 budget request, the Army asked for a lower authorized end strength because they cannot meet previously set goals.

The Air Force announced this week it will fall short by between 1,500 and 2,000 Airmen for each component of the Reserve and National Guard.

Young Americans' propensity to serve has dropped to historic lows. This comes at a time when only about a quarter of all young people are even eligible to serve, due to educational shortcomings, legal problems, and medical issues. Obesity has come to be considered a national security issue, as it prevents so many from entering the military. Committee members on both sides of the aisle expressed concerns about the public's inaccurate view of life in the US Armed Forces. Ranking Member Tillis (R-NC) said that the media, veterans, and even Members of Congress are spreading disinformation about the military, portraying it as a dangerous and toxic workplace.

# SENATE COAST GUARD AUTHORIZATION ACT OF 2022 INCLUDES PAY OUR COAST GUARD PROVISION

On Wednesday, September 14, the Senate Commerce, Science, and Transportation Committee passed the Coast Guard Authorization Act of 2022. The bill includes a provision that ensures that Coast Guard servicemembers get paid in the event of a government shutdown. This provision is strongly supported by The American Legion and the National Legislative Division is working diligently to ensure it remains in the final verion of the bill, which is expected to get added to the National Defense Authorization Act (NDAA) in October. In addition, this legislation will also help mitigate devastating climate-related events, invest in climate resilient Coast Guard infrastructure at places like Sturgeon Bay and will increase support for childcare, housing, and education.



#### AFGHAN ADJUSTMENT ACT

Two dozen veterans service organizations (VSOs) are pressing to have the Afghan Adjustment Act added to the CR. This legislation would create a pathway for eligible Afghans already in the United States to apply for lawful permanent residence after clearing additional background checks. The legislation would also provide assistance by fixing the Special Immigration Visa (SIV) process for the tens of thousands of Afghans who helped the United States during the war and who have been evacuated out of that country, but remain overseas.

Following the US withdrawal from Afghanistan, nearly 80,000 refugees were evacuated from that country. In addition to the uncertainties faced by those still in other countries, those who are in the US only have humanitarian paroles. This allows them to stay in the US for a year or two, and prevents them from building stable lives, according to the many immigration groups that have joined the VSOs in supporting this legislation.
