#### CONGRESS



Jennifer McClellan, recently elected to replace the late Donald McEachin, will represent the 4th District of Virginia in the US House of Representatives.

Neither the House nor the Senate were in session this week.

On Tuesday, Jenn McClellan won a special election in Virginia for a seat in Congress. The Democrat beat her Republican opponent to become the first Black woman representing the Commonwealth in the House of Representatives. The seat, in a heavily blue district stretching from Richmond to the North Carolina border, had been held by Don McEachin until his death last year.

Next Tuesday, the House and Senate Veterans Affairs Committees will hold a joint hearing with the Disabled American Veterans (DAV). Each year, the committees hold a series of hearings with veterans service

organizations (VSOs) to discuss priorities for the legislative cycle. **The American Legion and other VSOs will present to the committees on Wednesday**, and a third hearing will occur on March 8 with the Veterans of Foreign Wars (VFW) and other VSOs.

The House Veterans Affairs Committee, on Tuesday, has also scheduled a hearing on holding the Department of Veterans Affairs accountable. That same day, the House Appropriations Committee's Military Construction and Veterans Affairs Subcommittee (Milcon) will hold a hearing on military quality of life, most likely focused on housing and child care facilities.

### 2023 WASHINGTON CONFERENCE

The American Legion's Washington Conference will be back in person in 2023. This event allows our organization's leadership to meet with elected officials to discuss legislative initiatives and priorities important to Legion members and their families. It also provides a forum that allows Legionnaires to hear from senators, representatives, and officials from the Department of Veterans Affairs (VA) as they address our members at the conference. Commander Troiola will be testifying on Wednesday, March 1 at 10:00 AM.
