Chris Carlton (IN), National Commander: I now declare this 2023 Pre-Convention Meeting of the National Executive Committee of the Sons of The American Legion regularly convened.

As a point of housekeeping business, I would remind everyone addressing the Chair to please use one of the microphones in the aisles.

And it would help if you would tell us where you're talking from the floor so we can recognize and identify. Please name yourself, title and your detachment before speaking. This will help ensure that we maintain order and give our court reporter a better opportunity to document the proceedings correctly. Thank you.

At this time I will have National Adjutant

Anthony Wright read the minutes from our last meeting.

# Reading of the Previous Meeting Minutes Anthony Wright (PA) National Adjutant

"At 8:00 a.m. Saturday May 6, 2023, the National Executive Committee was called to order by

National Commander Christopher Carlton.

National Commander Carlton, good morning, everyone. The NEC responded good morning..."

Shawn Davis (MN): Commander, Shawn Davis,

NEC Detachment of Minnesota, the microphone ain't

working. I'd make a motion that we waive the reading

of the minutes.

... Seconded.

Shawn Davis (MN): Waive the reading and accept the minutes.

Chris Carlton (IN), National Commander: You make a motion to accept the minutes?

Shawn Davis (MN): As distributed and waive the reading.

Chris Carlton (IN), National Commander: As distributed, subject to corrections or additions.

Steven Cox (CA): Steven Cox, I second the motion.

Chris Carlton (IN), National Commander:
There's been a motion made and seconded. Is there any discussion?

John Lawrence (LA): Mr. Commander, John

Lawrence, Alternate NEC from Louisiana. Our NEC LeJeune had to step out.

Mr. Commander, NEC members and guests, I stand today as an Alternate NEC for the great state of Louisiana to comment on the minutes and events from the May 23rd meeting.

The Sons of The American Legion and The American Legion are organizations governed by our constitution and bylaws. December of last year, the Legion rolled out new constitution and bylaws for our organization.

These were not approved by this body. They were not approved by the membership, nor were they approved by National Convention. A select few stand behind the veil of The American Legion have ignored -- no, they have deliberately bypassed the written procedures and changed our constitution and bylaws.

Unfortunately, with them hiding behind The American Legion, we must accept this because it came from the Legion. However, the chosen few were not finished.

During our May NEC meeting, the chosen few

specifically and deliberately chose not to follow the written procedures and changed the rules of the NEC and the Uniform Code of National Convention.

There are no compelling reasons why we should usurp the power of this body.

By taking this action, the self-appointed chosen few have told the NEC, "You do not matter."

They have told all the members of this organization, "You do not matter."

They have told the delegates to our National Convention, "You do not matter."

Proud possessors of a priceless heritage.

Is this how we honor the sacrifices of our mothers and fathers that they made for our liberty to uphold and defend the constitution?

I believe this applies to our constitution and bylaws of this great organization.

To combat the autocracy -- it's time to combat the autocracy of the chosen few. The self-appointed chosen few are working to undermine our organization.

Why do we convene the National Executive

Committee or National Convention if a small group are going to hand down changes without passing them in front of the organization for approval?

Our Past National Commander and dual member while wearing his Legion hat on stage at our Spring NEC --

Chris Carlton (IN), National Commander: Excuse me, sir.

John Lawrence (LA): Yes, sir.

Chris Carlton (IN), National Commander:

I've just been informed by our parliamentarian that
this is discussion on the content of the motion made,
which, what I've been told is this being a speech, do
you have any concerns, discussion about the motion
itself?

John Lawrence (LA): This concerns the minutes of the meeting that we approved. You asked for discussion on the meeting minutes. And this relates to things that happened at the meeting and that are in the minutes.

Chris Carlton (IN), National Commander: I understand, but you need to state the discussion, not

a speech.

John Lawrence (LA): I am stating my opinion in discussing what happened at the meeting, to bring it to the forefront so that everyone here is clearly aware of how these changes came down and that they were not presented to this body for approval.

Chris Carlton (IN), National Commander: Do you have any other discussion on the minutes?

John Lawrence (LA): I would like to finish my presentation. Are you censoring the members of this organization now, too?

Chris Carlton (IN), National Commander:

No, sir. What I'm trying to do is conduct a meeting.

John Lawrence (LA): Yes, sir.

Chris Carlton (IN), National Commander: If you want to bring something up like that under the Goods, I would propose that. But right now there's a motion on the floor that's been seconded.

Is there any other discussion? Hearing none, all in favor say aye.

... chorus of ayes.

John Lawrence (LA): Nay!

Chris Carlton (IN), National Commander: All opposed, nay. The ayes have it.

... Gavel.

At this time, I ask the Sergeant-at-Arms to escort National SAL Liaison Kevin Mook to the podium for remarks.

#### Greetings

Kevin M. Mook (MD) National SAL Liaison - The American Legion

Gentlemen, here's the good part: I don't have anything prepared. That's a good thing.

... Applause.

But what I do want to bring up, bring to your attention, note at the top of the SAL national flag, there's a flag topper on it. Remember at my first meeting with y'all, in the spring of last year, I said, hey, would that be a good idea? It's done. It's now available at emblem sales.

... Applause.

We switched it out at all of our national flags. But it is available.

The next thing that's coming is Fridays,
y'all are wearing redshirts for a reason, right? Just

because it's Friday. No, to it's to remember everyone deployed.

Wouldn't it be kind of cool to have one that says "Sons of the American Legion" on it? That is sold at emblem sales. It's coming. It's coming.

And we now also have a welcome pack for new members. In the very near future -- I know better than to tell you when -- but in the very near future we'll be able to put -- people will be able to join online. That's the next step.

So we'll get rid of -- we have headquarters squadrons that are already built up in Personify, but they're built as 9999, most of them.

We'll get those changed and we'll make it to the equivalent of the Legion DMS program, so if someone joins online in the first two years and stays -- I'll explain all that later. But it's a resolution that I'm writing in the very near future that will happen.

Commander.

Commission Reports Chris Carlton (IN) National Commander At this time, we will receive some of our Commission reports. I call on National Internal Affairs Commission Chairman Bill Clancy to the podium along with National Membership Committee Chairman Thom Skelley. And Finance Commission is on deck.

# Report of the Internal Affairs Commission William M. Clancy, III (NY), Chairman

Good morning. Since our spring NEC meeting, the Internal Affairs Commission has continued our work on a number of initiatives including a welcome letter and promoting the newly developed welcome kit, which is available from Emblem Sales, which I thank Mr.

Kevin Mook to help to bring to fruition. Detachments can now -- I think we've talked about it in the past, but it's now available at Emblem Sales.

Since spring we received two resolutions which we have acted upon. And I can read them and I'll try to read them very quickly.

SAL Resolution 1, Pre-Convention 2023. The title is Authorize the National Adjutant to Correct Misstatements of Fact or Inconsistencies of Language in Adopted Resolutions Without Changing Intent. The

origin is Internal Affairs Commission.

"Whereas, resolutions adopted at National Convention or by the National Executive Committee of The Sons of the American Legion sometimes contain erroneous references to federal statutes or the official number of the bill pending before the Congress, or the intent of the resolution is obscured by language inappropriate to the purpose of the actions sought in the resolution or by the erroneous application of facts or law; and, whereas, it is recognized that such a situation develops under conditions calling for immediate action at a National Executive Committee meeting or at a National Convention; and, whereas, those charged with the responsibility of carrying out the action sought are frequently hampered by the imperfections of the resolution wording; and, whereas, no officer, representative or employee of the Sons of the American Legion is authorized to make any changes in or additions or corrections to any resolution adopted at a National Executive Committee meeting or a National Convention;

And, whereas, this situation is so serious as to warrant prompt and corrective action being taken now; therefore be it resolved by the National Executive Committee of the Sons of the American Legion, in regular meeting assembled in Charlotte, North Carolina on August 25th, 2023, that the National Adjutant be and hereby is empowered and directed to make such changes in resolutions as may be necessary to eliminate factual misstatement or language inconsistent with the clear intent of the resolution when taken as a whole -- and as evidenced by the deliberation of the body from which such resolution emanated.

This resolution was read at the IA meeting this morning, which took place after the IA convention meeting and was approved by the IA commission.

Resolution number 2 -- Pre-Convention 2023. The title being, to Rename the National Membership Committee.

Origin, from the National Membership and Squadron Activities Committee.

Whereas the Sons of the American Legion
Resolution NEC7-74 created the National Membership and

Squadron Activities Committee as a standing committee of the National Executive Committee; and, whereas, said resolution defined the purpose, scope, function, authority and membership of the committee;

And, whereas, the increase in national membership and need for clarity and continuity suggested a revision to the original resolution.

It is now in order; therefore, be it resolved by the National Executive Committee of the Sons of the American Legion in regular meeting assembled in Charlotte, North Carolina, August 25th, 2023, that the National Membership and Squadrons Committee be renamed as the National Membership Committee;

And be it further resolved that the committee shall continue to be a standing committee of the National Executive Committee, reporting to the Internal Affairs Commission;

Be it further resolved that the committee is charged with promoting the recruitment, renewal and reinstatement of members of the Sons of the American Legion;

And be it further resolved that the

committee should develop suggested programs and activities which may be used by squadron or other levels of the organization to promote service, camaraderie and membership;

And be it further resolved that the committee shall disseminate national membership and renewal reports through its assigned members as well as other duties germane to membership;

And be it further resolved that the committee shall be comprised of an appointed chairman, three core members of which one shall be named vice chairman, and several regional chairmen representing each geographical region as determined by The American Legion, all of whom should be granted voice and vote in the committee;

And be it further resolved that there may be one authorized National Commander's representative on the committee who shall serve with voice and vote and a number of consultants and/or advisors to the committee as deemed appropriate and necessary who shall serve with voice but no vote;

And be it further resolved that the National

Vice Commanders of the Sons of the American Legion shall serve as ex-officio members of the committee with voice but no vote;

And be it finally resolved that Sons of the American Legion resolution NEC7-74 is hereby rescinded.

This was, as well, acted upon by the Internal Affairs Commission this morning at our meeting and it was approved.

Butch Ray (IL): Mr. Commander, Butch Ray,

NEC from Illinois. Point of order. I'm confused that
these resolutions are not being read by a member of
the NEC. Did these go through the Subcommittee of
Resolutions previous to these being read?

Chris Carlton (IN), National Commander:

From my understanding they went through this morning.

We have the internal --

Nedley Fox (CA), Resolution Subcommittee

Chairman: Good morning, good morning. No, they have

not gone to the committee. Didn't receive them until

Sunday. The committee will meet after we're done

today at some point.

The resolutions will be presented, one way or another, at the post-convention. Anybody has any issues you need to go back and read what the book says.

The Subcommittee on Resolutions is supposed to meet two hours prior to the meeting. They're due in the Adjutant's office, in their hand, resolutions, at least 30 days prior.

Giving it to us on a short window, we have not had the opportunity to get the group together.

But we will be able to give you a recommendation at that point.

There is one resolution that we are prepared to present to the NEC at the proper time that dealt with the tri-fold. But the other ones, not happening.

Chris Cook (OK): Chris Cook, NEC, Oklahoma, correction. The resolutions that have to be presented 30 days prior to our meeting are any resolutions pertaining from a Detachment. Any resolution presented by the committee or commissions can be presented up until the day that the subcommittee meets. Thank you, Commander.

Butch Ray (IL): Thank you, Commander. You've answered my questions for now.

William M. Clancy, III (NY): As I would add, as the Internal Commission Chair, there's obviously been some timing issues of different people having a meeting.

Our meeting was this morning, so these two resolutions have gone through Internal Affairs and been acted upon by the Subcommittee of Resolutions. So at least note they've been through our commission.

Butch Ray (IL): Thank you, Mr. Chairman.

William M. Clancy, III (NY): That's my report.

Chris Carlton (IN), National Commander: I will entertain a motion to accept the Internal Affairs Commission report, minus the resolutions.

Marc Chaney (OR): I will make that motion to accept the Internal Affairs report, minus the resolutions.

... Seconded.

Chris Carlton (IN), National Commander: A motion has been made and seconded.

Is there any discussion?

Hearing none, all those in favor of accepting the Internal Affairs Commission report, minus the resolutions, signify by saying aye.

... chorus of ayes.

All opposed by saying nay.

The motion carries.

... Gavel.

I call on National Subcommittee on Resolutions Chairman Ned Fox.

# Action on the Internal Affairs Commission Resolutions Nedley C. Fox (CA), Chairman Subcommittee on Resolutions

I would ask, when you submit resolutions and go through the Adjutant's office, and if you're referencing an old resolution -- as an example, on one that's before us is -- from the national, I think it was the membership, yes, National Membership and Squadron Activities, it's reference NEC Resolution 774.

If you want the committee to be able to find it -- what did that resolution say, as opposed to what you're wanting to do, so that we can at least have an

opportunity to give you, to review it and present it.

It doesn't matter personally. We are not to take a position that I like it or don't like it.

That's not the job of the Subcommittee on Resolutions.

Ours is to make sure it meets the criteria for an effective resolution, that it doesn't go against any policy or procedure of The American Legion, and then the NEC or the convention has the opportunity to accept or reject.

So, anybody from membership, you have a resolution that is before us that we hope to act on for Sunday's post-convention. But if anybody has NEC Resolution 7-74, we would love to have that in our hands, please.

Resolutions that the committee has seen that came forward over a month ago -- and this is SAL

Resolution No. 3, and it was the endorsement of the

Sons of the American Legion National Veterans

Employment and Education Commission Tri-Fold Brochure.

Whereas, Sons of The American Legion is a volunteer program of The American Legion; and, whereas, the Sons of the American Legion are obliged

to adopt in letter and spirit all the great principles for which the American Legion stands;

And, whereas, the Sons of the American Legion, Veterans Employment and Education, VE&E, Commission is dedicated to supporting The American Legion by assisting The American Legion in ensuring that American's veterans can provide, with honor and dignity, the economic necessities of life for themselves and their families;

And, whereas, the Sons of the American

Legion VE&E Commission encourages the Sons of the

American Legion at national Detachment and Squadron

levels to assist in such vital endeavors.

It is incumbent upon the Commission to communicate these vital endeavors to the Sons of the American Legion at all levels;

And, whereas, the Sons of the American

Legion VE&E Commission has assimilated a beneficial

collection of references and information associated

with veterans employment, education, homelessness and

veterans in crisis assistance;

Now, therefore be it resolved by the

National Executive Committee of the Sons of the

American Legion, in regular meeting, assembled in

Charlotte, North Carolina on August 25th, 2023, that

the National Executive Committee hereby recommends the

Sons of the American Legion National Veterans

Employment and Education tri-fold brochure is made

available for distribution to the national Detachment

and squadron levels of the organization as deemed

appropriate by The American Legion National Veterans

Employment and Education committee.

And this came in from Jim Coates, the chairman of National Veterans Employment and Education Commission. And it has been reviewed and blessed by William G. Hill, chairman -- National Finance chairman.
