Remarks by Commission/Committee Chairmen

Daryl V. VerStreate, Jr. (NY), Nat'l Membership

Committee Chairman

I was asked to say a few words, but I'm not quite sure what to say. It's not often -those that know me, know after nearly 20 years of doing membership know that I can nonstop talk about it.

But after the year that we've had, 44 out of 55 detachments over 100 percent. As of Monday I have no doubt we'll be hitting 394,000 members.

Every region over 100 percent, two over

It's just phenomenal. Everybody in this room, when I think about that, I think about the

105 percent, what do I say to that?

Band of Brothers. It really takes every single one of you and the entire family working together to make those things happen. It doesn't happen because of me; it happens because each and every member in the national organization, with communication and a common goal.

So how do we beat that? You know what would be phenomenal? I tell myself 6,000 members is all we need by December 31st to end this year with 400,000 members.

It's not a question I can answer, but it's a question that everyone in this room together working can answer. Exactly, I think we can do it. I really do.

If everybody goes home, focuses on retention -- I know you've heard this saying before, but if you can just ask one, if you got one person, one veteran, one disabled person, one person in your squadron struggling, get that card, send it in and sponsor them for this year, I have no doubt by walking into fall NEC, that if we don't break it, we'll come close to it. I'd love to do

it by December 31st. I mean, it would be very nice, whether it's J.R.'s claims to fame or Commander Navarreté's claim to fame, but what it comes down to is it's all us.

This year I have a friendly competition.

And I love winning. But with something like this,

I don't mind losing, as long as we're improving.

With the National Membership Chairman of
The American Legion walking into the National
Membership Workshop next year, whoever has the
lowest retention rate will buy the winner a steak
dinner. Just something short, friendly
competition.

But we walked in just shy of 90 percent this year. They walked in, I want to say, just over 92 percent. We weren't that much further behind them. I would love to beat The American Legion, especially in retention.

But that being said, I'm going to keep it under five minutes. Thank you for all your hard work this past year. If we're going to beat next year what we did this year, we've got to continue

working together. Thank you, brothers, and I appreciate everything you've done.

NATIONAL COMMANDER NAVARRETÉ: Thank you, Daryl.

I also had the honor of addressing the Legion's Membership Workshop that weekend. And let me tell you, it's what ignited us to continue to push harder. We know how to recruit. We can retain. We just need to give it that little extra effort, and I know we can get it done.

I joked with my brother J.R. as we were at NEC, because we were getting close, and I told him I wouldn't be too upset if it didn't happen during his year, but at the same time, we're all winners, each and every one of us, because it's all of us together that collectively work these programs.

If there are any other chairmen that have any remarks at this time, please come forward.

NEDLEY C. "NED" FOX (CA): Ned Fox, chairman of the Subcommittee on Resolutions. Just

asking all the chairmen of all the various committee and commissions, that when you guys are involved presenting new resolutions out of your committees, if you could shoot me a copy so that at least we've got a heads-up and we can keep the communication flowing back and forth to help the process move, it would be greatly appreciated. Thank you.

NATIONAL COMMANDER NAVARRETÉ: Thank you, Chairman Fox.

JEFFREY J. VAN HORN (IL): Mr. Commander,
Chairman Van Horn, Finance Commission. We would
distribute checks after the Post-NEC, Brian Compton,
and I, at the back of the room.

NATIONAL COMMANDER NAVARRETÉ: Thank you.

PNC ROBERT A. WORREL (IN):

Mr. Commander, PNC Worrel, Indiana. Permission to approach?

NATIONAL COMMANDER NAVARRETÉ: Yes.

PNC ROBERT A. WORREL (IN): Thank you,

Commander. Just want to give you a brief update on
the 100th Anniversary. We were able to meet

Thursday evening.

I won't give you a full-blown report, but I want to give you an update for where we stand and ask for everyone to be involved. We need your input. This is, as Past Commander Hall has said, remember your why. The best way to honor your why is, as Commander Navarreté said, tell your story.

We have over 393,000 stories. This is our history. This is what we're about. We discussed a lot of things. I'll give you a few highlights.

We want to reach out -- the Detachment

Commander School, I spoke to them, asked them to

start considering forming 100th Anniversary

committees, and we want to work with them, the

National committee. We want to honor all three

levels. Squadron, detachment, national. We want a

complete, comprehensive history of our

organization.

We want to honor every phase going back. We want to break this down into 20-year segments where we can really honor each and every member of

the past, present and future of our organization.

We're working to create some type of clearinghouse where there's a place where you can submit your ideas, things that you found. You can ask questions. It will be monitored by the 100th Anniversary Committee so we can communicate.

I gave the detachment commanders my email information. Anybody that wants it, see me after the meeting. I'll give you a way to get in touch with me until we get something established so we can work together. We're trying to think of some ways to honor the longest chartered squadrons, just a lot of ideas are on the table.

We're creating a Challenge Coin series to start in 2027 and have a coin each year up to the 100th Anniversary. We want your ideas. Share with us what you think these coins should be and what they should represent.

This is all of us working together.

We're working on a brochure that's going to kind of
be the nuts and bolts, the how-to, what you should
look for when you're creating your history, the

important things, where to look, who to talk to.

We've got a lot of people with a lot of knowledge in this organization. Just reach out to them and just offering our assistance to help all of you. Thank you very much.

BLAIR MILES (AL): Mr. Commander, Blair
Miles, Convention Committee chair. First, I'd like
to thank the NEC for approving this new committee
and to let you know what it's all about, we want to
establish some continuity, some good things for
this National Convention now and in the future.

I think we can all agree that the

Detachment of Louisiana did a fantastic job, and
we're going to all leave here with some great
memories of what happened.

So what I'm going to ask of the NEC -this might be the craziest thing I've ever done -I want you to leave here and go home and think
about the things you've seen this weekend, the
things that you liked, you didn't like, the changes

that you would like to see. Some of the things that you've seen that could have been a little different.

I thought the timing was great this year. It's much better. But there's always still some things to work on. So give me an email, give me a text, phone call, say while this is on my mind -- we want to get ready for Tampa Bay and just have a great convention with less hiccups and a smooth run, and with your help, the NEC, we'll make that happen. So thank you, sir.

NATIONAL COMMANDER NAVARRETÉ: Thank you, Chairman Miles. Gentlemen, we've tried to start the groundwork to make our convention that much better. It started this year with Commander Hall.

Our planning sessions have been going on. You see we now have a commitment by having a committee to really drive the importance of not just making sure we have a good flow, we have something entertaining, and we're also taking care of business.

I was sad to see that we started off

without our Commander, but I want to tell you just something real quick: You saw me and our now leading candidate, Mr. Clancy, walking around, throwing out beads with jester hats.

That was because our brother, Mr. Hall, even though he was lying in bed, hurting, reached out and said, "I want you guys to do this."

What do brothers do? We step up and we take on the challenge. That's what we do.
