from your seat. Please ask the chair to be recognized -- telling us where you are on the floor helps -- then identify yourself by name, title, and your detachment before speaking. This will help ensure that we maintain order and give our court reporter a better opportunity to document the proceedings correctly. Thank you.

At this time, I will have National Adjutant Anthony Wright read the minutes from our last meeting.

Hearing none, all those in favor of accepting the previous meeting minutes as published signify by saying aye.

Motion carries.

The Sergeants-at-Arms are handing out the resolutions for the pre-convention NEC. So if you would stick your hand up so they know who to give them to.

FROM THE FLOOR: NEC gets them first.

NVC TERRY A. HARRIS (KS): NEC and Past National Commanders, please.

At this time we will receive some of our Commission reports.

I call National Internal Affairs

Commission Chairman Bill Hill to the podium along
with National Membership Committee Chairman Daryl

VerStreate, Jr. Finance Commission is on deck.

Oral Report

National Convention Internal Affairs Committee William Hill III (MD), Chairman

Thank you, Commander. You mentioned membership. They're actually meeting at 10:00 as well. I just want to make sure that was noted.

For the Internal Affairs Commission report, we've had a successful year so far. I took over in May. A lot of accomplishments we've had already in flight.

MT&Ds do an outstanding job. You saw today they conducted and coordinated the Commander's training. We have initial new training that we'll be outlining for the year to possibly expand to some adjutant training and some advisory training and other activities.

We've also been asked to potentially participate in some regional training that's going to take place. We're working on agendas and outlines for that. More information will be available for that at the fall NEC.

In general, the membership and squadron

activity also is doing a fantastic job. As you see through their and other's help, we're at 392,000 members right now. I won't steal all of Daryl's thunder that he's going to use to present tomorrow, but there's a slight possibility the way we're going right now with things, by the end of this calendar year, for 2024, we have a good likelihood of being at 400,000 members. So kudos to that group for everything they're doing in trying to get all that put together.

Also on the Convention Committee, they're working and moving forward and doing a lot of that.

As you'll see in your resolution

packages, IA put forward four resolutions or so to

be discussed today. There is one administrative

correction on the resolution for convention and

meetings committee that we put forward that we've

submitted. It's just an adjustment in the

membership makeup to incorporate the past, current

and future Detachment, where the convention is

going to be held, as key representatives on that

committee, so making sure that's inclusive of that.

I've talked to our liaison, Kevin. It's some administrative work within the resolution itself to incorporate that, but that's kind of the bottom line, just some adjustments of that one event.

At this time, Commander, that is my report.

NVC TERRY A. HARRIS (KS): I will entertain a motion to accept the Internal Affairs Commission report, minus the resolutions.

CHRIS L. COOK (OK): Commander, can we just not receive and file the report minus the resolutions?

BRANDON K. CURRY (KY): Mr. Commander, Brandon Curry, Kentucky, I second that motion.

CHRIS L. COOK (OK): Brandon Curry seconds the motion to accept the report from the IA Commission. I'll make the motion to accept his report. Chris Cook, Oklahoma NEC.

NVC TERRY A. HARRIS (KS): Chris Cook of the Detachment of Oklahoma makes a motion to accept the Internal Affairs Commission report minus the

resolutions. And the second was by Brandon Curry, NEC of Kentucky.

Is there any discussion?

Hearing none, all those in favor of accepting the Internal Affairs Commission report, minus the resolutions, signify by saying aye.

All opposed by saying nay.

... Gavel.

Motion carries. Thank you.

I call on National Subcommittee on Resolutions Chairman Ned Fox.

Oral Report

National Subcommittee on Resolutions Nedley C. Fox (CA), Chairman

Good morning, and thank you, Commander.

This report will be fairly brief, I hope. I'm

going to have to take some of Tony's space here.

The Subcommittee on Resolutions met yesterday afternoon, and I want to thank our committee of Brandon Curry, Jay Marsden was excused, Camille LeJeune, Steve Ward, Mark McCue, and Chris Sherman. And special guests, our National Adjutant, Mr. Tony Wright.

The previous minutes from the May meeting were approved.

CHRIS L. COOK (OK): Point of order,

Commander. Is the Subcommittee on Resolutions

giving a report, or are we voting on the

resolutions that are coming out of Internal

Affairs?

NVC TERRY A. HARRIS (KS): I believe he's giving his report.

CHRIS L. COOK (OK): Thank you.

NVC TERRY A. HARRIS (KS): I hope.

NEDLEY C. FOX (CA): Thank you. Now, on to the resolutions.

Resolutions 1, 2, 3, 4, 5, 6, 7, 8 and 9 were all candidate resolutions received through

Internal Affairs that had been received and filed.

We concur.

Resolution No. 10 was the establishment of the Lawrence Hartline Memorial Trophy. This was a cleanup on a practice that has been taking place on an award, and it's just now stated in there.

There was no change, nothing being added. And this

was approved by the resolutions committee.

Therefore, I'd like to make a motion that Resolution No. 10, the establishment of the Lawrence Hartline Memorial Trophy, be approved.

CAMILLE A. LEJEUNE, JR.(LA): Camille LeJeune, Louisiana, NEC, makes a motion to approve it.

NVC TERRY A. HARRIS (KS): Ned Fox,
California made the motion to approve. And the
second was by Camille LeJeune, Detachment of
Louisiana. Is there any discussion?

Hearing none, all those in favor of adopting Resolution NEC2024-prel0 signify by saying aye. All those opposed say nay.

SAMUEL JOHNSON (IA): Sam Johnson,

Detachment of Iowa. The copy I have, it has the
same "resolve" clause twice. The first "resolve"
clause and last "resolve" clause are duplicates.
So, to say we cleaned it up and then we have this
again.

NEDLEY C. FOX (CA): Administratively that will be cleaned up. And thank you.

NVC TERRY A. HARRIS (KS): Okay. Hearing none, all those in favor of adopting -- you already did that. The motion did carry. I'm sorry.

... Gavel.

NEDLEY C. FOX (CA): Resolution No. 11
was the establishment of the National Honors
Recognition Council. Its origin was the Internal
Affairs Commission. The committee met, discussed,
and approved this resolution. Therefore, I motion
to accept Resolution No. 11.

BRANDON K. CURRY (KY): Mr. Commander, Brandon Curry, NEC Kentucky, seconds the motion.

NVC TERRY A. HARRIS (KS): Ned Fox,

Detachment of California makes the motion to adopt

Resolution NEC2024-prell. And Brandon Curry,

Detachment of Kentucky, seconds. Is there any

discussion?

CHRIS L. COOK (OK): Commander, Chris

Cook, Oklahoma, NEC. Yeah, it's going to be on the

second page down here, item number 5, "the final

decision shall rest with the American Legion's SAL

commander's advisory committee."

Why are we establishing a council that will not make the decision but yet give a report to the committee that will make the final decision?

This seems silly and redundant. We also have a Past National Commander's Committee that can do all this and still report to that same committee.

PNC DOUGLAS P. BIBLE (MN): Mr. Commander Past National Commander Doug Bible. A question to the Internal Affairs Committee that submitted this resolution.

I guess I'm kind of -- what is the real purpose of this? Did we run into some incidents that is causing this council to be created? Or is this something to just pick out special individuals? Is it really a necessary thing to happen? Thank you.

WILLIAM HILL III (MD): I'll try to address both questions, and both very good questions, starting with NEC Cook's question.

The intent is to establish this as kind of an independent outside council to review this on an ad hoc basis when these are going through. The

oversight from SALCA just basically ties back to
The American Legion and the overall final decision
and review of that. That's part of that, Chris,
what that intends for.

Doug, your question, I don't have a litany of detail as to why other than when it was discussed, it's to help -- and this was also discussed at the spring NEC to a degree; and I would call any other PNC who wants to provide comment -- it was to somewhat establish a means and method to provide the right honor and respect to an honorary title that we may bestow on somebody, be it a Past National Commander or emeritus or such as that. It's not to any type of detriment.

I say this in this way, it's not to remove the emotion but to understand the importance of it. It's not an, okay, something happens today; we want to do something right now; it's an immediate ad hoc.

But also it runs parallel to even when a resolution may occur. Our new resolution process requires it to go in front of the American Legion

anyhow, the Resolution Review Committee.

So this is kind of another subset of that, to help clean that up and get that type of alignment for that overall process.

Commander, I'll defer back because I think there's a comment over to your right.

PNC DAVID R. FAUST (WI): David Faust,

Past National Commander from Wisconsin. Chairman

Hill said it very well. It's to prevent -- not

necessary prevent, but a situation where you have a

groundswell of something that happens in the spur

of the moment.

It's to provide more of a thoughtful process on bestowing any kind of honor, because we want these to be rare and special and not be something that starts occurring on almost an annual basis because somebody thinks somebody deserves it and then the resolution goes through, and everybody just goes along with it to get along.

I'm going to be very blunt. It's to make sure that we've got a good process in place to manage it and make sure these things stay rare and

special. Thank you.

PNC RAYMOND P. GIEHLL JR. (IN): Mr. Vice Commander, Raymond Giehll, Past National Commander, Indiana. He said "annually." I must have missed something.

Are we annually giving awards to people that don't seem to deserve them, or did I miss something? We've given two in the last five years. Before that there hadn't been any in a long time, all the way back to an honorarium for Pat Shea.

This just seems to be a way to control who gets what and when. Thank you.

william Hill III (MD): I can't comment on the "annual" because I agree with you on that.

This was not intended to prevent an annual because there have not been that many of a groundswell.

CHRIS L. COOK (OK): Commander, Chris Cook, Oklahoma NEC. I request a roll call vote for this resolution.

DAVID HANSON (IN): David Hansen, NEC for Indiana. I also request a roll call vote.

JON KINGSTON (TX): Jon Kingston, NEC,

Texas. I also request a roll call vote.

NATIONAL ADJUTANT ANTHONY W. WRIGHT (PA):

All right.

The vote calculation -- 33 - yes; 19 - no. And based on the two-thirds majority, 33, you passed.

NVC TERRY A. HARRIS (KS): All right. So Resolution NEC2023-pre2, the motion has carried.

... Gavel.

JACK YOUNGS (ID): Jack Youngs,

Alternate, Idaho.

Commander, I heard you say 2023. What I have on my paper says SAL Resolution 11

Preconvention 2024.

NVC TERRY A. HARRIS (KS): To be corrected. Thank you.

DAVID HANSON (IN): Commander, David Hanson, NEC, Indiana. According to my math, it takes 34 to make two-thirds of 52.

MARC CHANEY (OR): Mr. Commander, Marc Chaney, NEC, point of order. This is not a change to our constitution, so shouldn't it be just a simple majority?

NVC TERRY A. HARRIS (KS): Yes, that is correct.

... Applause.

NATIONAL ADJUTANT ANTHONY W. WRIGHT (PA):

I do stand corrected. I was actually just talking
with our parliamentarian regarding that, and that's
what he had just stated, that just the majority
ruled on that.

NEDLEY C. FOX (CA): SAL Resolution

No. 12, "Largest Squadron" Award. This is another

one of housekeeping, cleaning up -- the Largest

Squadron Award has been forgiven many years and it

wasn't to be found anywhere. So this is just the resolution to tell on you on the Largest Squadron Award.

So the committee has recommended approval. So motion to accept the SAL Resolution No. 12 for the preconvention.

NVC TERRY A. HARRIS (KS): Ned Fox,

Detachment of California makes a motion to adopt

Resolution NEC2024-pre12. Is there a second?

SAMUEL JOHNSON (IA): Sam Johnson,
Detachment of Iowa, seconds.

NVC TERRY A. HARRIS (KS): The motion is seconded by Sam Johnson, Detachment of Iowa.

Is there any discussion?

MARK A. CANNITO (SC): Mr. Commander,

Mark Cannito, NEC, South Carolina. Is this -- at

our last NEC we discussed changing the requirements

for growth allowing every squadron to be eligible.

Is that what this is discussing?

NEDLEY C. FOX (CA): No, just the largest squadron. That would be a separate issue.

MARK A. CANNITO (SC): Okay, thank you.

JUAN A. CRUZ-RODRIGUEZ (PR):

Mr. Commander, Juan Cruz, NEC, Puerto Rico. Just to clarify, what we discussed in the last NEC meeting was detachments that were under 200 members that were not qualified for certain membership awards. This is just talking about squadrons. Thank you, Mr. Commander.

NEDLEY C. FOX (CA): Thank you.

STEPHEN P. PINTARICH (CT): Steve

Pintarich, NEC, Connecticut. Is this based on a

number or a percentage?

NEDLEY C. FOX (CA): It is based on a number.

NVC TERRY A. HARRIS (KS): Is there any further discussion?

Hearing none, all those in favor of adopting Resolution NEC2024-prel2 signify by saying aye.

All opposed, say nay.

... Gavel.

Motion carries.

NEDLEY C. FOX (CA): SAL Resolution

No. 13, Preconvention. This was a Youth Initiative Videos that has been referred to Finance.

Resolution No. 14, this originated from Internal Affairs. This is the restructure of the National Convention Committee, Resolutions

Committee. Looked this resolution over and discussed our recommendation.

Motion to approve this resolution.

New Business

New Business, is there any New Business to be brought before the National Executive Committee?

JOSEPH SCHULTIS (IN): Mr. Vice

Commander, Joe Schultis, Alternate NEC, Indiana. I

wanted to bring up about the consolidated reports.

There was some missing reported.

In Indiana, we have 283 squadrons.

There's 102 recognized by national reported. We had down 159. These were recognized at National via email that they did receive these consolidated reports via the email process.

So that would have been a total of 261. That would be 92.23 percent that we had instead of the 36 percent. At my math, using \$32 an hour for volunteer hours, we lost out on \$4.4 million recognized. That's 780,000 hours.

So my issue is that because of this, the awards that will be given out this weekend are not

recognizing all the squadrons that worked hard for everything.

So I would like to propose a motion that it be noted before each of the awards by the CSRs that it is documented and noted that these awards are given out by the CSRs received by national in time and the ones recorded by national because there are a lot of squadrons that have been excluded at no fault of their own. Thank you.

NVC TERRY A. HARRIS (KS): We have a motion from Joe Schultis of the Detachment of Indiana. Joe, would you repeat your motion, please?

JOSEPH SCHULTIS (IN): My motion is that before each of the awards, it is noted that the awards are only counted for by the squadrons that sent in their CSRs on time and documented by national.

NATIONAL ADJUTANT ANTHONY W. WRIGHT (PA):
Here's what we'll do, just for clarification
purposes, I will request, if the motion passes,
that you put the verbiage down that you would like

to have stated, and we'll just do one blanket, one before the awards are presented.

JOSEPH SCHULTIS (IN): That's fine. I also have a copy for you if you would like, my data.

NATIONAL ADJUTANT ANTHONY W. WRIGHT (PA):
Perfect.

CHRIS L. COOK (OK): Chris Cook, NEC, Oklahoma seconds the motion.

NVC TERRY A. HARRIS (KS): We have a second from NEC Chris Cook, Detachment of Oklahoma.

Is there any discussion?

Hearing none, all in favor signify by saying aye. Those opposed, nay.

PARLIAMENTARIAN GARY B. LEACH (CA):

First, for clarification, I have no authority to

make a ruling as a parliamentarian, but I can make

a recommendation. Rather than having to go through

an entire roll call, the way you confirm the

outcome of a voice vote when it's uncertain is to

conduct a rising vote.

So that would be my recommendation and it

would save a lot of time. Just have those detachments who are here to vote, you would say all in favor, rise. Okay. Thank you, be seated. All opposed, rise. And determine the outcome that way. Much simpler than conducting another roll call.

MICHAEL GRAICHEN (RI): Michael Graichen,
Department of Rhode Island, Department Commander,
request a standing vote.

FROM THE FLOOR: Out of order.

NATIONAL ADJUTANT ANTHONY W. WRIGHT (PA):
All those in favor of the motion by Joe Schultis,
rise if you are for the motion.

FROM THE FLOOR: Can we have the motion restated?

FROM THE FLOOR: NECs only.

NATIONAL ADJUTANT ANTHONY W. WRIGHT (PA):

Joe, can you go to the microphone? I don't want to

put words in your mouth. So everybody sit down

until Joe's completed.

JOSEPH SCHULTIS (IN): The only thing I'm asking for is that it is only recognized that squadrons were left off. That's it. There were

squadrons left off. If we want to just state that, that there were some squadrons not documented, I'm good with that.

So I guess if I'm okay, I'll just make my motion that it was brought forth that there were squadrons, CSRs, not recognized.

So my original motion was to just make a statement at the beginning before the awards stating that all of these squadrons that are being recognized only -- all the squadrons being recognized had submitted their CSRs on time and the ones that were recorded by national.

NATIONAL ADJUTANT ANTHONY W. WRIGHT (PA):

Does that clarify everyone's, what his motion is?

I can't interpret what his motion is, and neither can the chair.

NEDLEY C. FOX (CA): Ned Fox, NEC California. We have a motion on the floor right now that was made by the gentleman. So if we want clarification to simplify it, it would seem that that motion would need to be rescinded so that you could restate the motion, maybe that will clarify

what you're looking for so that the confusion is taken away.

I understand what you're trying to do, but that would be -- we need to vote on the first motion, or it needs to be rescinded.

NVC TERRY A. HARRIS (KS): Mr. Schultis, would you like to rescind that motion?

JOSEPH SCHULTIS (IN): All I'm trying to get is that squadrons that were not recorded, that the national understands. And it's not just an Indiana thing, guys. I don't know how many squadrons out there were not recorded. So if this doesn't happen, all I'm saying is, why were we browbeat about getting these CSRs in?

I'll rescind the motion.

NVC TERRY A. HARRIS (KS): PNC Fox.

PNC MICHAEL FOX (CA): Thank you. I think what he's trying to get at is he's recognized that there's a problem with the recording of the CSRs on the national level. I think the best thing to do would be for an NECman to make a motion to direct somebody, whether it be the SAL or National

Headquarters, to fix the problem so that we can get that resolved so that all the squadrons' information is recorded, because we're missing out on a lot. Would that make more sense?

PNC DAVID R. FAUST (WI): Mr. Chairman,
PNC Faust. I agree with Mr. Fox. I think we need
to fix the problem. I understand where
Mr. Schultis is coming from 100 percent. There is
a problem with getting all of this paperwork
recorded and processed at National Headquarters in
a timely fashion.

We need to recognize that, but I also don't want to see us put an asterisk on every award that's given out this weekend and to make some feel like maybe they weren't worthy of getting it.

That's not their fault either.

So it's a tough spot that we're in, but I don't think we need to do this on the convention floor. I think the NEC needs to make a strong statement to national staff that we'd like them to look into this and fix it. Thank you.

NVC TERRY A. HARRIS (KS): Mr. Schultis.

JOSEPH SCHULTIS (IN): Joe Schultis,
Alternate NEC, Indiana. I'd like to make a motion
to have the National Adjutant work with National
Headquarters to recognize and fix the recording of
data problem that's been brought forth.

NVC TERRY A. HARRIS (KS): Are you amending your original motion?
