## FALL DETACHMENT EXECUTIVE MEETING AUSTIN, TX---SEPTEMBER 20-21, 2025

#### **SATURDAY, SEPTEMBER 20, 2025**

He presented another program concerning the established \$1,000.00 line item in the budget for grants that will be presented later. He also spoke about CWF items that are available for purchase. Some discussion was brought to the floor concerning background checks for anyone handling food for the pizza party. There were some other items brought to the floor discussion. Motion passed.

MARKETING—Chairman Hartline came forward to give his report. He stated that all new

shirts are not ready yet but should be soon and be available for purchase at the Mid-Winter Conference. All officers have received their shirts. He stated that there will be no cost increase starting next year. He also stated there are some Thom Skelley shirts available to purchase. A complete report is attached to these minutes.
