MID-WINTER CONFERENCE AUSTIN, TX---JANUARY 21, 2023

SATURDAY, JANUARY 21, 2023

Meeting was called to order at 9:01 AM by Commander Guillory. Colors being in place, a right-hand salute was given. Motion made by Jon Kingston, second by Tom Arista to pay the per diem that Robert would have received and present that check to Jan Sonnier. Motion passed. Motion made by Rich Huntley, second by Ray Hartline to pay the call-in for the new 7th District Commander to this Mid-Winter Conference. Motion passed. Commander Guillory then asked NEC Kingston to come forward for the Purpose of introduction. Jon then introduced Candidate for National Commander J R Hall, from the Detachment of Maryland, to come forward. J R Hall then spoke to the body and extending greetings to all from the National Organization. His comments were well received, and the body appreciated his comments. Commander Guillory then asked for the reading of the minutes. Motion was made by Milton Chatham, 2nd by Tom Arista to waive the reading of the minutes. Motion passed

PUBLIC RELATIONS---Chairman Ventura not present to give the report due to illness

Commander Guillory then recessed the meeting at 11:45 AM for lunch. Meeting was called back to order following lunch at 1:16 PM by Commander Guillory

INTERNAL AFFAIRS/MEMBERSHIP— Chairman Tom Arista came forward to give the report. He reported to the body concerning the status of membership in the Detachment. We are doing very well hitting our goals and just made the 60% goal. Eddy then presented some awards (caps and pins) to various Squadrons from 2022. There was various discussion concerning certification of officers and membership submitted on-line. There was some discussion concerning the salary for the Adjutant. Judge Advocate Austin came forward to inform the body of the changes to our By-Laws that have been approved.

NEW BUSINESS---Judge Advocate Austin read resolution of endorsement. Adjutant Winkelmann gave the body information on a 9th District Grant Writing Training class.

GOOD OF THE SAL---Various Squadrons reported on upcoming events. 1st Division Commander Perkins told the body about a bicycle trip from Brownsville to Oklahoma. Route and date will be published at a later date. Commander Guillory provided some encouraging notes to the body. Adjutant Winkelmann then discussed many Adjutant notes, upcoming events and future dates for meetings.

Are American Legion Posts and Squadrons Still Relevant?

Many industries were affected by the pandemic and The American Legion Posts and Squadrons were no exception. Posts and Squadrons across the country suffered and some were forced to close their doors forever. The American Legion is facing much uncertainty and many are fearful of what it all means for the future of the Legion.

The pandemic was an unfortunate wake-up call leading to the realization that this isn't Grandfather's American Legion Post any longer. Today's membership needs to be diverse, and complex and will have different priorities than those from decades past. Still, with questions surrounding the future of the Post and the Legion itself, some are left wondering: Are Posts and Squadrons still relevant in today's society? I certainly think so-at least, they can be.

The American Legion is abuzz with talk of changing demographics and evolving lifestyles and male-dominated households are no longer the norm. Instead, we see dual-income households, increasingly led by career-driven women, with parents who are equal in decision-making and looking for a comfortable environment for the entire family.

With the aging of the Baby Boomer generation comes the dominance of the even larger Millennial population-a generation looking for activities that fit their time-constrained social lifestyle-a place that welcomes spontaneity.

Since many Posts and Squadrons memberships have many generations of members it can be challenging for Posts and Squadrons to successfully cater to a wide variety of interests. Such an ambition requires striking a

balance among programs and services to appeal to a younger generation without alienating lifelong members. It's time for forward-thinking Post and Squadrons to accept this challenge and see it as more of an opportunity-a chance to reinvent themselves to provide what members are looking for. In actuality, it's more of a necessity than an opportunity if American Legion Posts wish to continue to play a significant role in members' lives.

Maya Angelou once said, "I've learned that people will forget what you said, people will forget what you did, but people will never forget how you made them feel." It's difficult to put a price on a feeling... it makes sense, then, that members are more willing to be a part of incredible experiences that create wonderful memories to last a lifetime. The goal is to provide an environment that helps them do just that.

At its core, a Post experience is its brand. While this "brand" has little to do with logos, colors, and typefaces, it has much more to do with every aspect of how a member engages with the Post and a lot to do with creating a unique culture that fosters a sense of community. Posts and Squadrons compete with members for their time. By investing dollars and resources into enhancing the overall Post experience, Posts and Squadrons can create a vibrant and energetic atmosphere where members want to spend their time and invite their friends to join them.
