



## LEGISLATIVE DIVISION UPDATE

Week Ending March 12, 2021

### **Congress**

Thursday afternoon, President Biden signed the American Rescue Plan (ARP), his \$1.9 trillion COVID supplemental spending bill. The bill passed both the House and the Senate on Party-line votes. The House's second vote took place on Wednesday, when they approved the revised version passed by the Senate last weekend, which costs about \$66 billion less than the original package, according to the CBO.

Appropriators continue to do background work on building the FY22 budget. The President's proposed budget is not expected to reach the Hill until sometime in May. In the meantime, House appropriators are already submitting their ideas for Community Funding projects, which are the newest version of earmarks.

In the Senate, Appropriations Committee chair Sen. Leahy (D-VT) is on board for bringing back "directed funding." He told reporters he would be willing to divide the amount so used with Republicans, should they choose to participate. However, committee ranking member Sen. Shelby (R-AL) noted the caucus would have to reverse its 2019 permanent ban on earmarks.

Tuesday evening, the House unanimously passed the VA Vaccine Act, which would allow the Department of Veterans Affairs (VA) to provide the COVID-19 vaccine to all caregivers enrolled in VA programs and to veterans living abroad who use the Foreign Medical Program. The bill continues to give priority to veterans enrolled in the VA to receive health care, although lawmakers have made clear they would like to have the VA vaccinate all veterans regardless of enrollment status. Senate Veterans Affairs Committee chair Sen. Tester (D-MT) has introduced similar legislation in his Chamber.

House Armed Services Committee (HASC) chair Rep. Smith (D-WA) issued a statement on Tuesday that he is "glad" the Biden Administration is willing to work with Congress to review authorities under the existing authorizations for the use of military force (AUMF). Smith said the 2002 AUMF should be repealed, and the 2001 AUMF needs "serious reforms."

### **House Armed Services Committee (HASC) Defense Supply Chain Task Force**

The HASC has formed a new task force to examine the Defense supply chain. Headed by Rep. Slotkin (D-MI) and Rep. Gallagher (R-WI), the group will take three months to identify supply chains with a national security importance and figure out how to ensure they are resilient in the face of crises. The goal is to have legislative language ready to insert into the next National Defense Authorization Act (NDAA), which usually gets marked up in the late spring or early summer.

The lawmakers have already asked the Pentagon to identify its critical supply list, vulnerabilities, and chokepoints in the supply chains, and what legislative steps would be needed to build resilience against future shocks.

At the start of the pandemic, the nation's reliance upon China for almost all medical supplies, from the mundane (masks and gloves) to the sophisticated (ventilators) was thrust into the spotlight. China immediately stopped most shipments abroad, as their population needed the supplies. Slotkin called this experience "searing", and said it should be prevented for future emergencies. Gallagher went further, charging that China "weaponized" key supply chains at a time of global need.

Slotkin said the White House has already taken action to improve domestic manufacturing and sourcing through executive orders. The task force will be looking at what Congress needs to do.

Gallagher said he is less focused on turning the government into a solely "buy American" purchaser. Rather, he wants to find a balance between what must be made domestically, what can be secured from allies, and where risks can be taken with a broader network of partners. The focus of this effort will not be on acquisition reform, both lawmakers emphasized.
