### SENATE FAILS TO MOVE FORWARD WITH VETERANS PACKAGE

Also on Wednesday, the Senate failed to move the Veterans Programs Improvement Act of 2023 (S. 326) forward. The legislation only got 57 of the 60 votes it needed to move towards final votes. At the last minute, Senate Majority Leader Schumer (D-NY) voted against the bill in order to preserve the option for bringing it up again. The package includes three pieces of legislation requiring the VA to conduct studies and clinical trials on the effects of cannabis use on PTSD, chronic pain, and other conditions many veterans experience. The legislative package also contains legislation to improve the family caregiver program, home and community-based services, and the home loan program, especially for Native Americans.

### GRASSROOTS ALERT: SUPPORT NEEDED THIS WEEK ON VETERANS' CAREGIVERS

On Wednesday, The American Legion emailed a grassroots alert that urgent action was needed to pass veteran caregiver legislation through *S. 326, the Veterans Program Improvement Act*. Unfortunately, this legislation failed to move forward – which means we need your voice now more than ever.

### CONGRESS

Next week, the Senate will be in session while the House holds a district work period. Several high-profile congressional delegations will be traveling around the world.

On Wednesday of this week, House Speaker McCarthy (R-CA) pushed through the 2023 Limit, Save and Grow Act to steeply cut federal domestic spending in exchange for raising the debt ceiling. The measure, which passed on a 217-215 vote (four Republicans voted against it), would result in an over 20% reduction in federal spending for FY24 and limit spending growth to 1% a year for a decade. In return, the debt ceiling would increase by \$1.5 trillion or be suspended until March 31, 2024, whichever comes first.

The bill is dead on arrival in the Senate. While few GOP Senators appear to favor passing a clean debt ceiling increase, the spending restrictions in the House measure are too extreme for most of them. A number of GOP House lawmakers are already pushing back at charges the bill would drastically cut the amount of money available for veterans' health care. Before voting for the measure, House Veterans Affairs Committee Rep. Bost (R-IL) released a statement that he has "letters of commitment" from McCarthy and other leaders that veterans' care would not be impacted. However, although the bill's language exempts the

Department of Defense (DoD) from cuts, there is no language protecting the Department of Veterans Affairs (VA) in the version passed by the House.

Although the House bill has virtually no possibility of becoming law, it does set the stage for further negotiations with the Senate, congressional Democrats, and the White House. President Biden has, several times, publicly stated that McCarthy has not brought anything to the table. With this in place, the White House now needs to make its own offer.

Appropriators in both chambers, in the meantime, are facing the almost impossible task of building FY24 spending bills without any realistic top spending amounts in place.

Wednesday morning, the Senate confirmed Joshua Jacobs as Under Secretary for Benefits for the Department of Veterans Affairs (VA). According to the VA, this is the first time since 2014 the Department has had a confirmed person for Under Secretary for Benefits, Under Secretary for Health, and Under Secretary for Memorial Affairs at the same time.

The House Armed Services Committee (HASC) is set to mark up its FY24 National Defense Authorization Act (NDAA) the last week of May, in hopes of having it on the floor the second week of June. While HASC chair Rep. Rogers (R-AL) would like to break the marathon markup into two days, this year is likely to be a repeat of going late into the night.

### HOUSE VETERANS' AFFAIRS COMMITTEE TO SEND SEVEN BILLS TO THE HOUSE FLOOR

Today, the House Committee on Veterans' Affairs held a Full Committee Markup, advancing seven bills that would increase transparency at VA Medical Centers, increase leadership stability at VHA, and increase the rates of compensation for veterans with service-connected disabilities, and other issues essential to ensuring VA can deliver healthcare and benefits to America's veterans.

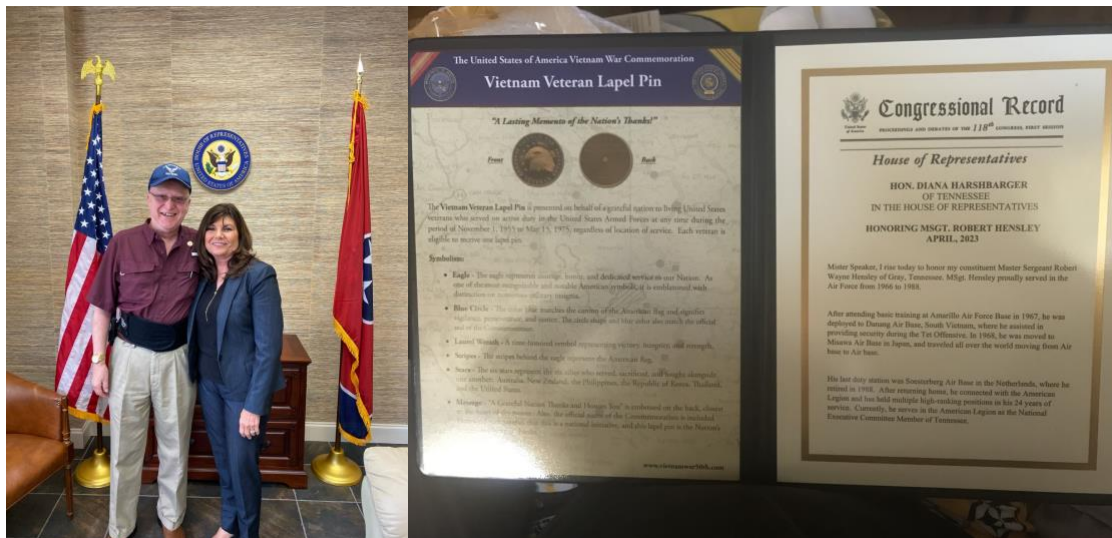
