Group developing Veterans Memorial Park

Two weeks ago, the Veterans Memorial Park received the new organization's nonprofit designation. There has been little dust settled since organizers announced the proposed construction of a park just south of the Byron Cox American Legion Post on South Washington Street.

Members of the nonprofit board, the Crawfordsville-Montgomery County Chamber of Commerce and other community members came together Monday for a ceremonial ribbon cutting for the project, which will honor all veterans.

The idea of constructing a park to honor veterans started with board member Bill Durbin. He was visiting Fairmount five years ago and saw the city's impressive display and brought the idea back to Montgomery County. The idea caught the attention of several

veterans, and a committee was formed to turn the idea into a reality.

"I was in Fairmount for the Jimmy Dean Festival and drove by their American Legion and noticed this veterans memorial park," Durbin said. "Fairmount's park is very nice, and I immediately thought we might want to do something like that in Crawfordsville."

Durbin and others, including Mike Spencer, Mark Eustler, Marc Gable, Bob Carstensen and Kevin Cobb have formed a local board to oversee the plans. Initially, the group wanted to use the Army Static Display Program (Tacom), which distributes condemned or obsolete Army equipment for static display purposes. But the men soon realized it would take a while to get a donated item, so they decided to start the project with private donations.

"We thought we could get some things from Tacom, and the Legion applied," Durbin said. "We qualify for equipment for display, but we were told it could be six or seven years for them to have something to send us. We are in line, but we don't know when we will get anything from them. We didn't want to wait any longer, so we are raising private donations."

Plans for the park include a restored 1969 Huey helicopter used in the Viet Nam Conflict as a centerpiece for the park. There also will be nine flags, including all six military branches. The flags will be displayed around a 30-foot circle made of 7,000 bricks surrounding a six-foot granite marker. Local painter Flip Walters will create a patriotic-themed mural on the storage shed at the rear of the property.

Organizers hope to have all the brick paid for by donations. For \$100 per brick, any resident, business, or organization can purchase a brick and have three lines engraved in the brick in honor of any veteran. The brick will be black. There will be special white bricks for any veteran who was killed in action, missing in action or a prisoner of war.

In just two weeks, the board has raised \$20,000 for the project, which is estimated to cost \$120,000. The price includes construction and maintenance of the property.

"This is a perpetual memorial, and we will continue to add more displays as we have them," Cobb said. "We are asking anyone who has an item that we could display to contact us."

Board members also want the memorial to help educate generations to come about the men and women who have served their country in the armed services.

The Veterans Memorial Park is not directly associated with the local Legion. However, the Legion men and women have a keen interest in the park and will do what it can. The Sons of the American Legion has already donated to the project.

“This is not the board’s park or the Legion’s park,” Cobb said. “It is the people’s park.”

The Huey helicopter will be ordered soon. It will be painted with a shark’s mouth on it similar to one a member of the local color guard served on in Viet Nam. It is estimated Phase 1 of the park, which includes the flag display and Huey helicopter, will be completed in the summer of 2024.

Palou, Ericsson now focused on Indy 500



The month of May in Indianapolis is in full swing at Indianapolis Motor Speedway (IMS), with practice this week leading up to this weekend's qualification for the May 28 Indianapolis 500. But for The American Legion, things really were kickstarted last weekend, [thanks to a dominant effort by Chip Ganassi Racing \(CGR\) and Alex Palou](#).

Driving the No. 10 American Legion Honda featuring the “Be the One” initiative, Palou won the GMR Grand Prix on IMS’s road course by nearly 17 seconds, the largest margin of any INDYCAR victory this season. Palou and the rest of CGR’s drivers now are shifting their focus toward the Indy 500, won last year by Ganassi driver Marcus Ericsson. Palou will drive The American Legion livery again in the 500, while Ericsson’s No. 8 Huski Chocolate Honda also will carry American Legion branding.

This Friday, the fastest speeds of the month will be on display when each car will receive a turbocharger boost to reach the speeds they will run during Armed Forces Qualifying, which will take place Saturday and Sunday. On Sunday, the 12 fastest qualifiers will compete for a spot in the Firestone Fast 6, which will determine the first two rows of the Indy 500 starting grid.

Palou currently sits atop the INDYCAR SERIES, thanks to last week’s win and three previous top-five finishes, while Ericsson is in third place and won the season opener in St. Petersburg.

Palou, who finished second in the Indy 500 in 2021, led 52 of 85 laps in the GMR Grand Prix and heads into the INDYCAR SERIES’ biggest race with confidence. In his two previous Indy 500s driving for CGR, Palou has qualified in the first two rows while leading 35 laps in 2021 and 47 in 2022.

“I’m feeling pretty good for the Indianapolis 500,” Palou said via CGR media. “We’ve been really fast the past two years. I think we just need to try to get the strategy right, get more confident in traffic and just get a clean day. We have the championship lead, which feels amazing, and we need to keep it and go for the Indianapolis 500, as well.”

Ericsson is gunning to become the first back-to-back Indy 500 winner since 2002. If he does so, he’ll earn a bonus of \$420,000 courtesy of BorgWarner, the namesake of the Indy 500 trophy.

“The Month of May is here, and I can’t wait for everything, honestly,” Ericsson said. “It’s going to be amazing and I’m looking forward to be here competing as the defending champion. It’s an exciting month ahead. Let’s do it.”

MILTON, Ga. — Barge "Peter" Stoios, Sons of the American Legion Post 201 member and former Fulton County Schools bus driver, died in a car accident May 6.

Police responded to the call at around 10:51 p.m. that night, and upon arrival, determined Stoios had been ejected after attempting to negotiate a curve in his 1990 Mazda Miata on Birmingham Highway. According to the police report, a preliminary investigation indicated his vehicle left the roadway, struck a power pole, and spun off the roadway.

[A GoFundMe page](#) has been set up for Peter's memorial expenses, with \$3,490 a \$5,000 goal raised. According to the page, he leaves behind two daughters, Sophia and Jacquelyn. Any leftover money will go toward the cost of their trip to Australia, Peter's home country, to spread the ashes.

"He was the most loving father one could hope for and will be missed terribly," Sophia said.

A Celebration of Life will be held for Peter Sunday, May 21 at 3 p.m. at the American Legion Post 201 on Wills Road.

Armed Forces Day honors warriors and peacekeepers

May 17, 2023

Dear American Legion Family members and friends,

The American Legion's commitment to "preserve the memories and incidents of our associations in all wars" is without question. It is explicitly stated in the Preamble to our organization's constitution and recited by our members at every official American Legion meeting.

The third Saturday in May is set aside not just to honor those who served in war, but the men and women who comprise the greatest military on the planet. The first Armed Forces Day was announced on Aug. 31, 1949, by American Legion Past National Commander Louis Johnson, who was serving as the secretary of defense at the time.

There are other days in which we honor our military. Memorial Day is when we remember those who made the ultimate sacrifice for this country. Veterans Day is when we honor all veterans, regardless of where and when they served. Armed Forces Day marks what President Truman called "readiness for any eventuality."

It is significant that Armed Forces Day was observed after the horrors of World War II and prior to our entry into Korea. It recognized that there are always dangers and sacrifices involved with military service and that



America should always be appreciative of those defending our freedom in both war and peace.

Some members of the Armed Forces don't really feel that Veterans Day is for them. I have to confess that when I was in the Navy, I thought of myself as more of a sailor than a veteran. I couldn't have been more wrong. The American Legion believes that you are a veteran from the day you report to basic training. It is why you are eligible to join our organization from day one. It is also when you start following orders from your military superiors and delivering on your oath to "support and defend the Constitution of the United States against all enemies."

The American Legion has always recognized that a strong national defense is vital to the prevention of war. It is why the founders of The American Legion included defense as one of our organization's four pillars.

Legion post's namesake comes home after 80 years

The night before his mission to bomb oil refineries around Ploiesti, Romania, U.S. Army Air Force 2nd Lt. Pharis E. Weekley was told to pack his B-4 bag and write a letter home. The mission he was preparing for later became known as "Black Sunday" as it was one of the greatest losses for the USAAF in World War II. Pharis, 21, wrote his final letter home that read, in part, "Mother, when you see the newspapers and you read about the Ploesti raid, just know that I'm right there with them."

On Aug. 1, 1943, Weekley was a navigator in the nose of a B-24 Liberator nicknamed "Lady Jane" that set out on one of the largest air raids named Operation Title Wave. His plane was shot down by enemy anti-aircraft. And his remains went unaccounted for.

Until now.

After nearly 80 years, 2nd Lt. Pharis E. Weekley's remains were identified and brought home.

Four generations of Weekley's family welcomed him home to Florida, including his 94-year-old sister Marva Weekley-Turner, as well as his brothers and sisters in arms, The American Legion.

A celebration of life was held for Weekley on Saturday, May 13, at his Legion post namesake – the Dana-Howard-Weekley American Legion Post 130 in LaBelle, Fla. "To have one of our namesakes actually accounted for is pretty humbling. I can't imagine my child not coming home. I can't imagine that feeling of not knowing," said Post 130 Commander Myra Johnson, who has a 21-year-old daughter. "I was excited that there's finally some closure for everybody. Not just the family but for even our post. Everybody in the post was just so excited to be able to say, he's home. So we wanted to make sure that we honored the family, we honored his sacrifice."

Weekley-Turner and her family were escorted by Legion Riders from American Legion Post 69 in Avon Park, Fla., where she and her family live, to Post 130 in LaBelle.

Seeing the Legion Riders and other Post 69 members lined up outside Post 69 brought tears to Weekley-Turner. Her daughter and Weekley's niece, Cathy Albritton, said, "We thought we were the only ones that cared. We had no idea it was any bigger than us until we met (Post 69 Commander) Larry Roberts. We learned so quickly that The American Legion is our extended family. That they are there for us; for anything we need. They are the most wonderful, caring people. They have taught me this is how we treat our own. He's our brother, and we do not leave him behind ... 80 years later, he is not left behind."

Weekley-Turner had the option to have her brother buried at Arlington National Cemetery or sent home. After seeing the outpour of support from The American Legion and community members, "I'm happy that I said, 'Send him home.'"

The Legion Riders all had a patch on their vests that was a photo of Weekley with the inscription, "Welcome Home Weekley! 80 Years Never Forgotten." Challenge coins also were made and handed to his family.

Roberts said that the family didn't know the magnitude of services The American Legion can provide, "and what we wanted to provide. We will never leave a fallen comrade. This gentleman has been missing for 80 years; we're not going to leave him behind. That's one of my brothers. And finally, one of my brothers is home."

At 10 a.m. last Saturday, kickstands went up and the police-led hour-long escort was underway. Along the route, people stood outside businesses to wave American flags and show their respect, and yellow ribbons were tied to trees and a banner that read "Welcome Home 2nd Lt. Pharis E. Weekley" hung between fire-truck ladders outside Post 25.

"We could not believe there would be so many people. It makes us see how many people are patriotic and how many people are thankful for our freedom," Weekley-Turner said. "It makes us realize that we all are patriotic."

Turner, Albritton, Wesley (Turner's son), two granddaughters and two great-grandchildren arrived to Post 130 before noon along with hundreds of Legion Riders. The post was packed with Legion Family and community members there to meet the family, enjoy a free lunch, see photos and newspaper clippings of Weekley and to celebrate "Pharis as the son, brother, the person who was willing to give his life for his country," Johnson said.

Before the war. In high school, Weekley wanted to join the football team but his mother, Naomi Weekley, was worried he would get hurt. So unbeknownst to his mother, Weekley joined the boxing team. She soon found out when he came home with a busted lip. He too was an Eagle Scout and a gifted singer, often singing for the second wife of Thomas Edison at her tea parties.

Following the war, an Army chaplain wrote the family saying that Weekley would be greatly missed because he always led the singing during services. His favorite song was “My Task” which will be sung at his funeral service May 20 by his great niece, Brittany.

After graduating from Fort Myers High School in 1940, Weekley attended college at the University of Florida. When war broke out, he left college to serve.

“He said, ‘We just got to get this war won. We’ve got to get it behind us. And the only way is for us to volunteer, join, fight, and get this war over with,’” Turner said about her brother. Before his deployment overseas, she received a final gift from him. She was just 14 years old. But it is one that she has and still wears to this day – a gold bracelet and necklace. “I’ve always treasured it because it was a gift from him,” she said.

Missing in action. The news of Weekley missing in action came via a Western Telegram that his father had to retrieve from the local drugstore in downtown LaBelle. Then the second telegram came declaring him killed but still unaccounted for. But with a mother’s love unmatched, Naomi held on to hope that her son would return home.

The Weekleys owned a furniture store downtown where the Greyhound bus station was. “My mother, whenever the Greyhound bus would come in, she told me, ‘I could not help but go to the front door and watch people get off of the bus and just maybe this is not true, maybe Pharis will get off of that bus,’” Turner shared. “It was hard. It was hard.”

Weekley had turned 21 a few weeks before his final mission. His remains were buried as unknown in the Hero Section of the Civilian and Military Cemetery of Bolovan, Ploiesti, then moved to the Ardennes American Cemetery and Henri-Chapelle American Cemetery in Belgium where they remained until 2017.

Even though she was never able to see her son come home, Naomi kept a scrapbook of his entire life that has been passed down. “My grandmother kept everything. Every letter he sent (while in war), every letter she sent. Everything in the newspaper; everything

about Pharis Weekley was in this scrapbook,” Albritton said. “That’s how the story of him went through the generations. We have two grandsons with us today (at the Post 130 celebration of life). So we will continue to talk about the last few days with them. As long as we keep talking about it, they’re going to remember it. And this will be a generational story.”

The homecoming. Turner and her younger brother, Dallas, gave their DNA to the Defense POW/MIA Accounting Agency (DPAA) in 2014. “They called me and said, ‘We don’t leave anybody behind’ ... but I didn’t expect this to happen,” Turner said. “It’s just overwhelming that we’re able to bring him back.”

The DPAA began exhuming remains from the Operation Tidal Wave mission in 2017. And on July 12, 2022, the remains of U.S. Army Air Force 2nd Lt. Pharis E. Weekley were identified.

The DPAA called Albritton to tell her the news and that they felt she should share it with her mother. She went to her mother’s house, told her to sit down, and shared that her brother had been found. “As soon as I told her, a flood of emotions came over her. She couldn’t believe it. She cried and cried. If it wasn’t for the efforts of the DPAA, none of this would be happening.”

Weekley’s remains were flown into Orlando airport on Friday, May 12. Eight American Legion Riders from Post 69 and 130 were there with the family to welcome the flag-draped casket and to then meet up with a larger contingent of Riders to escort Weekley and his family through Avon Park to the funeral home.

It was closure for Marva. “Particularly, seeing the casket come off the plane,” she said through tears. “I can’t even express ... there’s no way I can express and to thank our government for continuing to look for all the boys.”


Weekley will be buried in Avon Park on May 20 beside his mother and father.

American Legion Riders and Legion Family members will again be at the funeral service to show their support.

“The American Legion has provided the most amazing support and love and comfort,” Albritton said. “I knew they did a lot for our community and for different organizations in our community, always been aware because of the great work they do. But this side ... this side.”

A form of that comfort came in the way of 90-year-old Post 69 Chaplain Ann Farrell, who put her arm around Turner as prayer was said over her brother's casket and before the Legion Riders departed Post 69 Saturday morning.

"It's really just such an honor for me at my age, I've never had anything like this happen before. It's a one in a lifetime experience," said Farrell, a Korean War era veteran. "I think this is something that they will treasure forever."
 Roberts added, "It's what we do. That's what The American Legion does."
