Meetings

- NS Staff conducted a follow-up meeting with experts from the Niskanen Center to discuss border policy and the role of foreign policy in securing the southern land border.
- NS Staff attended a Department of Defense (DOD) IGA Webinar on Sexual Assault Prevention. The meeting discussed results from the most recent report on sexual assault in the military, which can be read <u>here</u>.
- NS Staff attended a reception honoring the anniversary of the GI Bill.
- NS Staff attended the Department of Veterans Affairs Commemoration of the 80th Anniversary of the GI Bill.
- NS Director met with HR to begin interviewing and hiring for a vacant National Security Policy Analyst position.
- NS Staff met to continue detailed planning for hosting over 30 distinguished and Commission guests for the national convention. Detailed logistical and administrative planning critical to executing a successful convention is ongoing.
- The NS Director attended a meet-and-greet hosted by the Executive Director to welcome Ms. Tahina Montoya, the new Senior Advisor/Director of Veterans Engagement, Office of Public Engagement, from the White House.
- NS Director joined the Executive Director for a Veteran breakfast with Governor Youngkin in Richmond, VA.
- NS Staff attended a meeting with Colonel Masaka, the Defense Attache at the Embassy of Japan, to discuss a range of veterans and military affairs.

Policy

- NS Staff provided statements of support for three house appropriations bills: the Defense Appropriations Act, the State, Foreign Operations, and Related Agencies Appropriations Act, and the Homeland Security Appropriations Act.
- NS Staff is assessing the best way to consolidate various resolutions on border security to streamline and modernize the Legion's policy regarding transnational criminal organizations and their impact on America.
- NS Staff began researching the cost of malnutrition in the military for DOD and the Defense Health Agency (DHA).
- NS Staff continued working with wounded warriors to research and report on the Feres Doctrine. The lack of clarity surrounding "incident to service" was the investigation's root.

• NS Staff attended a DOD update on Sexual Assault. These updates are critical for informing the NS Staff on efforts which can better a veteran or service member's life and address potential issues surrounding sexual assault related trauma.

Focus Topic: The Significance of Protests in Kenya

Background:

Since decolonization in 1963, Kenya has maintained diplomatic ties with the United States. Although relations were strained by the ruling party's repressive behavior, attempts to democratize in the late 1990s and 2000s allowed U.S.-Kenya engagement to expand. The 2019 Bilateral Strategic Dialogue (BSD) solidified the strategic partnership between the U.S. and Kenya, emphasizing mutual interests in economic prosperity, defense, democracy, regional stability, and public health. Already, this partnership is proving to be fruitful. The following are key developments:

- Kenya is one of the U.S.'s top trading partners in Africa and is negotiating a new trade deal.
- The U.S. and Kenya signed a 5-year defense cooperation deal, targeting al-Shabaab and other Al-Qaeda affiliates.
- Kenya received about \$680 million in foreign assistance in 2023, largely to help curb food insecurity and solidify the medical supply chain.

Current Challenges:

President William Ruto was elected in 2022 on a "man of the people" platform, often referring to his pastoral upbringing. But his government's ever-increasing taxes are threatening his popularity. Despite deadly protests last year that came after new taxes were introduced as the cost of living was on the rise, this year President Ruto recently supported a plan to increase taxes through 2027. This includes taxes for car owners, a 16% sales tax on bread, 25% duties on cooking oil, and increased prices for baby diapers and other sanitary products.

Members of Parliament (MPs) approved these taxes as law this week, igniting a new round of protests that quickly devolved into violence. According to the Human Rights Commission, 23 people were killed and 300 were injured in the uproar where Kenyan police forces fired live ammunition into the crowds. The United Nations (UN) has called on Kenyan police to act with increased restraint, and the African Union has expressed deep concern about the events.

On June 25, 2024, President Joe Biden also condemned the violence in Kenya. This castigation comes only a month after President Ruto visited President Biden in Washington, D.C. and agreed on a joint mission to strengthen democracy and stabilize Sub-Saharan Africa. President Biden also designated Keyna as its first major non-NATO ally in the region.

On June 26th, 2024, President Ruto declined to sign the tax bill into law and sent it back to parliament for reform in an act of self-preservation. Ruto said, "It is necessary for us to have a conversation as a nation" and that he was ready to concede to "ongoing dissatisfaction." There is still skepticism about the bills future and President Ruto's policies among Kenyans.

Looking Ahead:

If he wishes to maintain his domestic legitimacy, Ruto will likely have to reject the bill outright, rather than returning the bill for amendment. But even this move may be seen as too little, too late to many Kenyans who continued to protest his government on Thursday, June 27th. It appears that the tax bill was merely a catalyst for protests, while a more deeply seeded mistrust in Ruto and his government has given them stamina. Kenyan youth are now calling for President Ruto to step down.

If Ruto loses legitimacy and is ousted from the presidency, the geopolitical implications could be disastrous. While democratic backsliding has plagued Western and Sub-Saharan Africa for a decade, Kenya has been one of the few African nations to progress towards a more fair and open society. If Ruto is ousted without proper elections, or remains in power without popular consent, yet another democracy in Africa will fall and regional instability will escalate.

Moreover, the U.S. and other Western powers will lose a crucial ally in a region where China and Russia are increasingly popular. As stated previously, Kenya is a key trade partner for the U.S. and a stronghold against terrorist forces, who are increasingly backed by Russian mercenaries. Backsliding in Kenya would not just pose a risk an ideational risk to U.S. influence, but could generate tangible, negative ramifications for American security and financial prosperity.

Health Policy Team Operations

Meetings:

- June 23 27: Health Policy Analyst Matthew Cardenas and Andrew Petrie conducted a System Worth Saving (SWS) site visit to the VA New Mexico Healthcare System.
- June 24: Health Policy Team (HPT) met with the American Association of Nurse Anesthesiology (AANA) to discuss research regarding Certified Registered Nurse Anesthetists (CRNAs) and scope of practice in the Department of Veterans Affairs (VA)
- June 25: HPT attended the VA press conference on the data breach of VA partner "Change Healthcare" in February. VA claims there have been no adverse patient effects. There has been some additional backlog in claims processes.
- June 26: HPT attended the Department of Defense (DoD) Webinar on Sexual Assault Prevention, where DoD and VA representatives provided an overview of the efforts and changes related to preventing sexual assault and harassment, as well as providing support for survivors. Prevention efforts are prioritized and are well-resourced; independent reports have demonstrated improvements, but work must be continued to sustain progress and disseminate resources.
- June 27: HPT met with Maxim Healthcare services. This organization offers compassionate care in the home to individuals with chronic and acute illnesses and disabilities. The meeting detailed how these service offerings could potentially enhance the quality of life within the veteran community.
- June 28: HPT met with representatives from SyncMD. The meeting centered around how this security innovation can help streamline the veteran claims process and improve access to healthcare.
- June 28: HPT and Legislation Team participated in a roundtable discussion with the Congressional for Country Caucus on Emerging Therapies.

New Projects: This week, Interns started two new projects:

1. Veterans' Education and Training Programs Evaluation:

- Interns will be looking into veterans' education and training programs such as the GI Bill, VET-TEC, and SkillBridge, and evaluating their effectiveness.
- Interns will begin working on a white paper dealing with a number of potential issues that these programs have.

2. Veterans Education, Training, and Credentialing Binder:

- Interns will create a binder comprising all veterans' education, training, and credentialing benefits/programs.

On Thursday, June 27, Division staff and interns attended the U.S. Department of Veterans Affairs Benefits Administration's celebration of the 80th Anniversary of the Signing of the Servicemen's Readjustment Act of 1944. The American Legion played a vital role in the creation of this landmark piece of legislation and continues to advocate for improving veteran education benefits. At this event, staff and interns heard remarks from VA officials, other VSO staff, and several veterans who have been positively impacted by the GI Bill.

Division Staff/Intern Activities:

- Division Staff and interns had the opportunity to search for resources for two incarcerated veterans. One of the veterans needs housing, while the other seeks job opportunities to be eligible for parole. Through working to help incarcerated veterans, interns have learned to extend empathy to people who society often deems undeserving of grace and compassion. Crime is often viewed as black-and-white, with no grey area, but it is usually more multi-faceted. Lack of financial stability, lack of support, and mental health problems can intersect with crime, making some veterans more vulnerable to entering the Criminal Justice System. Addressing homelessness and employment is essential to combating crime. Interns have noted that they find it extremely special and heartening that the Legion is willing to advocate on behalf of all veterans, including those who are incarcerated.
- Division Staff has been compiling our previous research on local veteran homeless shelters and resources into a binder. Having these resources easily accessible will offer aid to struggling veterans who call the Legion in search of support. These organizations extend beyond local posts to create an even larger support network for veterans experiencing financial hardship.
- Division Staff and interns have worked on coordinating visits between the Legion and veteran homeless centers in New Orleans, where the Legion is hosting its 105th National Convention. The division is also donating supplies to these shelters based on the shelter's needs.
- Division Staff met with Centene to discuss employment opportunities for transitioning service members, veterans, and spouses. Centene provides access to high-quality

healthcare, innovative programs and health solutions that help families and individuals get well, stay well and be well. Employer partnerships are crucial to seeing that the military-connected community has access to all available opportunities. Staff consistently seeks out these partnerships to ensure that these opportunities remain available.

Small Business

Division Staff/Intern Activities:

- Division Staff completed the Small Business portfolio training guide, which comprises all the small business programs available to current service members, veterans, spouses, and disabled veterans. This portfolio includes all loans offered by the Small Business Administration for veterans and every form of testimony and resolution The American Legion has produced in the effort to make the lives of our service members, veterans, and their families as prosperous as possible. This comprehensive training guide allows us to have all the information involving veteran-owned small businesses in one place, enabling us to hit the ground running when it comes time to advocate for further legislation that will better aid our service members.
- Division Staff is creating an Excel sheet that will contain all the events hosted by the Yellow Ribbon Reintegration Program. The sheet will be organized by month and will include information on which unit will be hosting each event and whether it is a virtual or in-person event. If you or anyone you know is interested in any of the upcoming events, the sheet will also have the link to register for that event various topics pertaining to veteran-owned small businesses, and to develop policy initiatives based on the information collected.

Objectives:

- **Information Compilation:** To gather and organize information about veteran-owned small business programs into a user-friendly binder.
- **Resolution Research:** To identify and analyze the American Legion's past resolutions related to veteran small business ownership.
- **Impact Analysis:** To assess the evolution of business startup costs and regulatory requirements impacting veteran entrepreneurs.

- Division Staff has been compiling previous research on local veteran homeless shelters and resources into a binder. Having these resources easily accessible will offer aid to struggling veterans who call the Legion in search of support. These organizations extend beyond local posts to create an even larger support network for veterans experiencing financial hardship.
- Division Staff and interns worked on coordinating visits between the Legion and veteran homeless centers in New Orleans, where the Legion is hosting its 105th National Convention. The division is also donating supplies to these shelters based on the shelter's needs.
- On June 27, 2024, Division Staff and interns attended a House Veterans Affairs Committee hearing While at the hearing, members investigated the VA's response to tracking homelessness and their budget of 3.2 billion dollars. Issues that arose included the lack of accurate reporting of veteran homelessness in both rural and urban areas and the failure to address the root causes of homelessness, often linked to mental health, childhood trauma, and dignity issues.

Proposed solutions consisted of more transparent and centralized data gathering and more individualized care addressing the root cause of an individual's experience with

homelessness, utilizing the By-Name List. These solutions emphasized the importance of addressing underlying issues beyond financial instability.

The hearing was notably impactful due to Congressman Eli Crane's remarks, where he expressed that the root cause of his issues upon returning from five tours as a Navy SEAL was related to problems with his soul and mental health, not his finances. Congressman Crane's testimony was particularly meaningful given his representation of the state of Arizona, where one of the Division interns calls her home State.
