## SAL National Awards: Don't Miss out on these Application Deadlines

Some important deadlines are coming up for Sons of The American Legion; here are the details and deadlines for awards - forms for these awards and more are available here.

**Squadron Commander of the Year Award:** Nominations for this award must be submitted by the detachment adjutant and received at National Headquarters by the opening of May's Spring NEC meeting. Nominees must be a member in good standing in the SAL; hold only the office of squadron commander at the time of nomination; demonstrate leadership through action and involvement in squadron activities that benefit his community; and must obtain 100% squadron membership or better by March 15.

Marvin P. Nay Veterans Employment and Education Outstanding Contributor Award: Nominations for this award must be received prior to the May Spring NEC meeting of the Veterans Employment and Education Commission meeting. The award will be voted on at that meeting and presented at the National Convention in August. Nominees must be a member in good standing in the Sons of The American Legion engaged in the fundraising, distribution of funds or goods, and/or volunteering at an event deemed beneficial to veterans' employment and/or education, to include homelessness. A detachment may submit more than one nominees, and an SAL member may nominate himself.

**All-Time High Honor Ribbon Request:** Pursuant to Resolution F3-85, the All-Time High Detachment Honor Ribbon (Red) will be awarded at National Convention to a Sons of The American Legion detachment which has exceeded all previous years' membership. The form should be reported to National Headquarters when an all-time high for membership occurs for the applicable membership year.

**Charles B. Rigsby Veterans Affairs and Rehabilitation Volunteer of the Year Award:** Squadrons should submit their nominee to the detachment adjutant during the detachment convention once the nominee form has been attested by the squadron or post commander. The appropriate detachment officials should select one nominee for award consideration and the detachment adjutant should forward the nomination form to National Headquarters no later than 30 days prior to the National Convention to be considered.

**George B. Evans Grassroots Veterans Advocate of the Year Award**: This award recognizes an SAL member in good standing who has performed outstanding service and made significant contributions in time and effort to grassroots veterans' advocacy work. An award may be presented each year to a member who takes on a bold leadership role by building relationships with elected officials who directly impact public policy; by actively taking the message of the national Sons of The American Legion to key media outlets; and by developing strong grassroot initiatives. Nominations may be submitted by an individual, squadron, district or detachment and are due by July 20.

#### Editor, "The Millennium" Editorial: Make the Most of our Conference in DC

We put an article in *"The Millennium"* last month about the upcoming Washington Conference, but I'd like to expand on that. Last year was my first time attending, and I'd love to share why this has become one of my favorite events to participate in as a Son.

The event happens at the end of February each year, where members of The American Legion and Legion Family make their way to our nation's capitol to meet with lawmakers and discuss the Legion's legislative agenda and priorities, concluding with the National Commander appearing before Congress. This year is the 65th Conference.



Americanism, though, is the primary focus of what the SAL does at the Washington Conference through their annual wreath laying program. Each year, the two National Commanders and National President place a wreath at the Tomb of the Unknowns, plus the detachments place wreaths honoring those who have served and sacrificed at the memorials along the National Mall. It's a

moving experience, to say the least. This year's schedule is in blue on Page 3.

But beyond that, Washington, DC is filled with things to do relevant to our history and to being the seat of

government—so you should take full advantage of being there and get in as much as you can. Plus, it's a great time to enjoy it with family and friends—especially kids.

Last year, two of my fellow Sons from my home squadron in New Jersey and I hopped an AMTRAK for the three-hour ride down the Northeast Corridor. With the three of us never having attended the Conference, we weren't quite sure about what was going on-but from what we had read, it looked like a cool experience. We went early on Saturday-a day early-and



left on Monday night. That gave us three days in the city.

Having been down to Washington to visit the museums and memorials with family since I was a kid—and since then doing it with my children—I was appointed play the role of tour guide. We arrived at Union Station before lunchtime, and took a Metro to <u>Arlington National Cemetery</u> to walk the grounds on our own before we did so with everyone else.

If you are a seasoned public transit person used to taking trains, or should this be your first time, rest assured ... <u>Washington, DC's</u> <u>Metro</u> system is quite easy to figure out. We traveled everywhere that weekend either by subway or Uber.

We had previously done research about specific internments at Arlington which we wanted to visit (you can look up individual memorials or markers here). Of course we would visit the Tomb of the Unknowns, but

we also visited some of our state's heroes buried there—PFC Henry Svehla, a Medal of Honor recipient from Belleville, NJ, GySgt John Bassilone from Raritan, NJ, a memorial to the Four Chap-

> lains (one of which is from Kearny, NJ), and the monument to the USS Thresher which had a serviceman from Nutley on it. We brought a few SAL Challenge

Coins with us, and placed one on each marker after observing a moment of silence.

"Breathtaking – there is no other way to describe it other than breath-

taking" noted Richard Vlasakakis, Essex County Adjutant and member of NJ Squadron 105.

There is a lot of walking involved, and a good deal of hills—so anticipate your visit to Arlington to taking a few hours. You should also think about doing it independent of the Sunday wreath laying so you can see as much

as possible. There is also a Tram.

Beyond Arlington, the National Mall is filled with places to visit. Stretching over two miles from the Lincoln Memorial on the west end to the U.S. Capitol on the east end, The Mall is lined with endless memorials and museums. The Sunday events place wreaths at the World War II and Vietnam War memorials, but there is also the Korean War Memorial, the Lincoln Memorial (don't forget the small often overlooked museum to the left when you walk in), the US Capitol (you can schedule tours online at www.visitthecapitol.gov), the Washington Monument, and the handful of other memorials just steps off of the Mall-the Franklin Delano Roosevelt Memorial, Thomas Jefferson Memorial, Martin Luther King, Jr. Memorial, and the Dwight D. Eisenhower Memorial (behind the Air and Space Museum).

Completed in the Fall of 2024, there is the <u>World War I Memorial</u> located a block or two from <u>The White House</u> in Pershing Park on 15th Street and Pennsylvania Avenue.

This isn't even to mention <u>The National Ar-</u> <u>chives</u> where the founding documents rest, and other places like <u>Ford's Theatre</u> and the <u>Supreme Court</u>.

The crown jewel of any trip to DC isbe the museums, though—which are all free. The <u>Smithsonian Institute</u> is made up of <u>17 DC-area museums</u>, plus the <u>National Zoo</u> (which




is not at all close). Our Belleville contingent truly enjoyed time at the <u>Air and Space Mu-</u> <u>seum</u> (which requires you register for a <u>timed-entry</u> <u>pass</u>), and the "Price of Freedom" exhibit at

the National Museum of American History.

About 30-miles south of downtown Washington is another Air and Space Museum, located in Chantilly, VA. <u>The Steven F. Udvar</u> <u>-Hazy Center</u> is located near Dulles Airport, and is HUGE—with a space shuttle, an SR-71, and the Enola Gay B-29 at the location.

First and foremost, the Washington Conference is about the American Legion's legislative priorities; I write this "tour guide" with embedded links because I hope you will taking full advantage of all Washington, DC has to offer as well. We hope to see you there!

## SAL National Awards: Don't Miss these Application Deadlines (cont'd)

Some important deadlines are coming up for Sons of The American Legion awards; Here are details ... <u>forms for these awards</u> and more are available here.

**Blue Brigade Award:** Any SAL member who signs up 30 or more new members into the Sons of The American Legion by July 22 is eligible for this award.

**Individual Membership Recruiter Award:** Any SAL members who recruits five new members into the Sons of The American Legion during the current membership year is eligible for this award. Award forms must be submitted by June 30.

## SAL Media and Communication Awards

Snapshots of Service Award: Submitted photos must be based on the Four Pillars of The American Legion — Americanism; Veterans Affairs & Rehabilitation; Children & Youth; or National Security - and be in a digital JPG or TIF format. Submissions also will become the property of the SAL; must not have a right of restriction; must contain Sons with their covers or identifiable clothing on during the activity or event and a brief history of the event. Entries must be submitted from a squadron, with a maximum of three photos per category, and submissions must be from the current time period (Aug. 1, 2024 to 30 days prior to the National Convention). Click here for the application.

Videos of Service: Video submissions must contain an SAL member or members wearing SAL covers or SAL-branded clothing participating in an activity or event that falls under one of three categories: program support; community engagement; or membership and recruitment.

The video must be no longer than five minutes in length and have been posted on social media. Judged on quality, content and branding. <u>Click here for the application</u>.

#### American Legion Media and Communications Contest

The Media and Communications Contest is open to the entire American Legion Family to showcase their work promoting the organizations in various media channels.

There are seven categories for submissions:

- websites
- publications
- visual media
- social media campaigns
- editorial/news writing
- editorial/informational writing
- and public relations/community outreach.

Entries are broken into four divisions to select – departments/districts; over 750 members; 250-749 members; and up to 249 members.

You may enter submissions in one or multiple categories. Each submission will cost \$5. All entries must have been published during the 2024 calendar year.

Enter the contest by visiting <u>legion.org/</u> <u>media-communications-contest</u>. Deadline for submissions is April 15.

Winners in each category receive a plaque and are considered for the Innovation Award and Chairman's Award (a "Best in Show" honor), which include a plaque and a \$50 Emblem Sales credit.

Innovation Award: This rewards innovation in media. Nominees may submit for this but don't have to for consideration. Judges will consider the award winners and other nominees to select a winner that demonstrated true innovation.

Chairman's Award: A "Best in Show" award. Nominees don't submit specifically for this. The judges consider award winners and select one that goes above and beyond the others.

Media & Communications Commission members and National Headquarters staff select the category winners, which go before the entire commission for approval.



Over the weekend of January 24-26, 2025, members of the Sons of The American Legion embarked on a meaningful journey to Las Vegas, Nevada, to attend Wild Willy's Western Rendezvous, an event focused on Americanism training. #### From a letter distributed by PNC's Gene Sacco (CA) and Byron Robichaux (LA) about helping the victims of the LA Wildfires:

Since there are so many SAL members living in the small community of Palisades that have had their family's lives destroyed by the fire, over 17 that we know of, I am trying to put together a relief fund to help them. Their homes, schools, places of worship, stores and businesses have been burnt to the ground.

The estimate is 5,000 homes have been destroyed. I have talked to many and they are in shock and still don't know what to do. Local, state and federal help is coming in slow and their insurance companies are telling them they must wait 7 to 14 days before filing claims.

The Detachment of Georgia has already raised \$1,000 for our SAL victims, and the Detachment of California is in the process of voting to fund the relief fund. I am wondering if all of you can compel your detachments and get some donations out of your detachments and squadrons to help these poor souls. 

## Participants of Boys and Girls State may qualify for \$10,000 Scholarship

High school juniors who attend an American Legion Boys State or Auxiliary Girls State program this summer and are a direct descendant (or legally adopted child) of a military veteran may be eligible for the Samsung American Legion Scholarship.

The Samsung American Legion Scholarship is available for high school juniors who participate in the current session of American Legion Boys State or Auxiliary Girls State and are a direct descendant (or legally adopted child) of a U.S. military veteran who served honorably on active duty during a period of war (April 6, 1917-Nov. 11, 1918; or Dec. 7, 1941, until a date as determined by Congress).


The 2025 Samsung American Legion Scholarship application is online. Apply here.

All applications must be submitted using the online application system. Scholarship applicants must complete and submit their online application prior to 11:59 p.m. (local time) of Day 1 of their respective American Legion Boys State or American Legion Auxiliary Girls State program.



The scholarship awards up to \$10,000 for undergraduate studies (e.g., room and board, tuition and books). Each applicant is selected according to his or her involvement in school and community activities, academic record and financial need.

A Boys and Girls State participant from each state is selected as a finalist for the Samsung American Legion Scholarship. During the American Legion's Fall Meetings in October 2025, the Committee on Youth Education will select the scholarship winners. All scholarship recipients will be notified of their award.

VA and R Report

Before I get into a program that one of our commission members is working on this year, I would like to talk about a recent issue and an upcoming event at our VA's nationwide.

First off, you have all heard about the recent federal hiring freeze. This usually is not a great concern for us, but this freeze is different from years past-this time around VA volunteers are now involved in the hiring freeze. I am sure your first thought is ... what? We are volunteers, we do not get paid, we are EWOC's (employee without compensation). Though technically right, volunteers who work four hours or more a shift receive a meal stipend. And, it has been brought to my attention that to onboard a Regularly Scheduled (RS) volunteer, a VAVS Representative or Deputy Representative costs VA \$1,000. The paperwork, training, blood tests, background check, finger printing, badging, and for some positions a physical exam all add up - and add up all the volunteers across the country, well that turns into real money.

So, how does this affect us? If you are currently a RS Volunteer or a Rep/Dep, it is business as usual. If you have VA assignments, continue ... we are not affected. The same goes for our Occasional (OCC) volunteers, you do not go through the onboarding process as you volunteer a couple of times a year - so, please continue with your events. But as of right now, the VA cannot accept any new RS volunteers or Rep/ Deps. This all said, we can still take applications for RS volunteers and for Rep/Deps. Those applicants can be partially on-boarded and when the freeze is lifted, they can complete the process. I will say that in conversations with VA Central Office (VACO), they are trying to get an exemption for VA volunteers. Trust me, I understand how frustrating the last few years have become volunteering at our VA's. First it was the COVID, and the VA removed volunteers from serving for quite some time—with many volunteers not coming back. And just as we are getting back to "normal", we have the new rebadging process that I explained in my last article. Now we have a hiring freeze. Please do not let this deter you from serving those who have served us, because my brothers at the

end of the day our mission as Sons of The American Legion is what President Lincoln told us in his second inaugural address: *To Care For THEM Who Shall Have Borne The Battle. (Yes, I changed one word.)* 

Salute Week is also fast approaching at our VA system - seven days to say Thank you. Here is the who, what, where, and why from the VA.

The purpose of the National Salute to Veteran Patients Program is to:

- pay tribute and express appreciation to Veterans
- increase community awareness of the role of the VA medical center
- encourage citizens to visit hospitalized Veterans and to become involved as volunteers

The week of February 14 each year is your opportunity to say thank you to a special group of men and women ... the more than nine million veterans of the US armed services who are cared for in Department of Veterans Affairs medical centers, CBOC's, outpatient clinics, domiciliaries, and nursing homes. During this National Salute, the VA invites individuals, veterans groups, military personnel, civic organizations, businesses, schools, local media, celebrities, and sports stars to participate in a variety of activities at their medical centers. The activities and events include special ward visits and Valentine distributions, photo opportunities, school essay contests, and special recreation activities and veteran recognition programs.

The week also provides an opportunity for the community to become acquainted with the volunteer opportunities within the VA medical system.

So, if you have the chance during those seven days, see what the VA closest to you is doing ... you can drop by for a few minutes to say thank you.

#### Commission member Eddy Seegars from Texas is also promoting Camp Hope—here is his report on this little-known program.

Camp Hope is peer-to-peer counseling for PTSD sufferers. Studies have shown that peer-to-peer work has the highest of success rates when one veteran is sharing with another veteran, and thereby helping counseling each other. Because of that, they created this camp outside of Houston with the help of a local radio commentator who promoted it for several months on his radio program. They got the program set up, and they have had an enormous success rate as far as getting PTSD survivors back into society functioning, doing well, and coming on board as helping becoming counselor themselves. It has been just a wonderful success ... so much so that they are starting to spread out a little bit more, and opening some more camps. They are also looking into opening female veteran camps now as well - and when we say camps, it is more a dormitory style place where everyone is there together. Counselors can be there for the residents, and the residents can be there all the time ... and if they have a problem, they can get immediate help and have somebody right there with them. On a Texas state VA tour, I was able to visit the female veteran's facility in Waco.

The holidays have come and gone, and our veterans in all facilities get a little lost in the shuffle until the next big holiday. Try to remember them and visit if you can.

## Tennessee Legion Family at work during the Hurricane Helene

Receiving plaques at the Detachment of Tennessee's Mid-Winter Conference for "Selfless Service and Dedication", Squadron 21 members Caleb Jenacaro and Patrick McLaughlin were recognized for their relief efforts during Hurricane Helene. 1st District Tennessee Commander Scott Foulks and Post 49 Commander Paulette Baldwin were recognized as well.

Starting on September 27th, 2024, Caleb Jenacaro and the Parrottsville Volunteer Fire Department participated in the 183 swift water rescues that were conducted in response to the flooding from Hurricane Helene. Jenacaro is a member of Squadron 21 Rogersville, as is Patrick McLaughlin. McLaughlin participated in the same rescues, though with the Cocke County Swift Water Rescue Team.

Parrottsville FD, along with Jenacaro, performed rescues in the Parrotsville community, along with assisting Del Rio Fire Department along with other departments in Cocke County, Tennessee. Their operations lasted for more than 36 hours, with a good portion of that time being directly in the water. Patrick and his team did much of the same—including rescuing nine people trapped standing on the hood of a car. Hurricane Helene was a horrible initiation to the Swift Water Rescue Team for Patrick, having only completed the training one month prior, having joined the team two weeks prior to the hurricane.

During this time Parrotsville Fire Depart-

ment even lost one of their apparatus when their brush truck was engulfed by the rushing waters of the flood. When this happened, it was Caleb who had to go get the firefighters. The actions of Parrottsville and Caleb Jenacaro greatly contributed to the fact that Cocke County only lost two residents to drowning through the entire disaster.

Jenacaro and McLaughglin are both members of Riders Chapter 21 as well; Jenacaro also serves as the 1st District Riders Chairman and is the Chaplain for the Detachment of Tennessee.

The "Cowboy Commander": American Legion 1st District Tennessee Commander Scott Foulks, who is a member of the SAL as well, has been totally dedicated to accounting for all Legionnaires since Hurricane Helene, immediately working in Cocke, Carter, Washington, Unicoi, and Greene Counties. However, in the Northeast corner of Tennessee, with so much destruction the struggle to account for every Legionnaire loomed large. Phone lines and cell towers were completely down across all of Johnson County, and this made the task next to impossible. Undeterred, Commander Foulks organized teams to go knocking on doors to check on membership ... even going as far as to using side-by-side off-road vehicles and even horses to travel on what used to be roads. Earning the nickname "Cowboy Commander" around the Department, he went above and beyond to make sure every Legionnaire and Legion Family member was safe. He continues to work in the District daily to ensure our Legionnaires are getting what they need. His work ethic and dedication are the true definition of selfless service.

Barrington recalled the time he transferred Marvin into the squadron. He asked what squadron is the other fastest growing squadron in the state, which began a friendly competition between squadron 416 and Kenosha Squadron 21.

1st District Vice Commander and Squadron 21 Commander Michael Hellquist took on this challenge—and having never met each other before, a rivalry began. "What started as a friendly competition turned into a real friendship that I was hoping to last much longer." Michael recalled. "I received a message from Terry Barrington, asking what I was doing for membership, and we would bounce ideas off each other. We would just sit and discuss friendly combined ventures, and how we can work together. After Marvin and I each received our Blue Brigade awards, Marvin reached out to me to invite me to his squadron meeting so we could finally meet. ## consin's Richard A. Bennett

A proud U.S. Army Veteran signs up his newly born son, Richard, to Sons of The

American Legion Squadron 57 in Elgin, Illinois. That was on October 8th 1940, when the dues were 25 cents а year. Joe F. Bennett served in the US Army in WWI, where he was discharged a second time as a Sergeant. He was a gion Post 57, in Elgin, Illinois, where he was an active mem-

ber of the Drum and Bugler Corps Band for many years.

Richard was the only son, as he has two older sisters and one younger sister. Richard listen to his mother's colorful stories as she worked in show business before settling down and having a family. Richard started





father's printing company as a teenager, and by 18 age was fullworking time alongside his father. There he learned all the dirty jobs of printing, as he worked his way up in the business. Upon father's

his death, Richard took over managing Bennett Printing. However, this was not Richards

true calling for his life's career, though he kept the family business going strong and sold it in 2012.

Richard is one of the few people still alive that can say that he had been water skiing on Devils Lake with a motor boat. Devil's Lake is a Wisconsin State Park, which was established in 1911 with several "cottages" located on the shores of the lake. Richard's family had Number 70, which was located on the north east side of Devil's Lake. Today there is a picnic area and parking lot near their cabins location. They never could sell their cabin as the State of Wisconsin bought out their rights, and the Bennett owned it for 60 years. Also interesting, on the south side of the lake Henry Ringling built a cottage, which was known as the south Side Lodge in 1918. Ringling then had to build a road to



get to it, as steam boat was the only mode of transportation to get there. Later, a rail road line was developed. The original cabins were purchased by the state, and were grandfathered in to have motor boats on the lake. Only four cabins remain to-

day on the southwestern shoreline, and only electric motors are allowed on the lake.

Perhaps Richard's mother's show business career stories influenced him more than anyone really knew. In 1964, Richard became a Professional Show Clown-named "Raz-Bo" and was a regular for circus' and parades. Over the years, Richard traveled across the country and met many interesting people, including befriending Larry Fine of "The Three Stooges." Richard retired from show business in 1980, and went back to the career he started in 1962 through 1964. He also still had the vision to develop land with scenic view for housing. So from 1980 to 2023, Richard was a land developer and a house flipper-all the while keeping up on his membership within the Sons of The American Legion. It was soon after 2018 that Richard, now a 77 year member of Squadron 57 in Elgin, transferred his membership to Wisconsin's Squadron 491 in Cazenovia. As he had moved from Elgin to Baraboo, WI. This is the area that his family cabin had been in, and where he had so many fond

Legion meetings afterward. He volunteers to help out at the many meals served, often bussing the tables and dishwashing. Richard also donates food, and even cooks at home for the meals. About five years ago, Richard donated a large outdoor sign to advertise the American Legion Post. While he owned Bennett Printing, Richard donated all sorts of printed goods to the squadron and the post.

Richard is not one to sit idle for long, as he not only has a vision but has the motivation to see a project to the end. Richard also enjoys painting on canvas, and displays his work throughout his Baraboo home. Richard also takes pride in his collections, such as his WWI museum, his circus clown memorabilia, and his car collection ... one of which, a convertible, drives in local parades in representing the Sons of The American Legion. In December 2024, Richard helped to assemble goodie bags for school kids from 1st to 12th grade with his Legion family.

In 2025, Richard A. Bennett is an 84 year continuously member of the Sons of The American Legion, still at the Detachment of Wisconsin's Squadron 491 Cazenovia. His membership literally started on the day he was born - October 8, 1940 - making Richard the oldest continues member of the Sons of the American Legion in the State of Wisconsin!
