# Health Policy Team Operations

## **Meetings:**

- April 26: Health Policy Team (HPT) attended the Lesbian, Gay, Bisexual, and Transgender (LGBT) listening session hosted by the Department of Veterans Affairs (VA) Center for Minority Veterans (CMV), to listen to minority Veteran Service Organizations (VSO) about unique barriers to care LGBT veterans experience.
- April 29: HPT conducted a Town Hall at Post 1 in Phoenix, Arizona to identify challenges, areas of improvement, and potential solutions to VA care.
- April 30-May 1: HPT conducted a System Worth Saving (SWS) site visit at the Carl T. Hayden Veterans' Administration Medical Center to identify facility challenges and best practices.
- May 1: HPT met with the Patriot PAWS Veteran Coordinator Team to discuss the application process and challenges that veterans face in obtaining a service dog, as well as potential attendance at National Convention in August.
- May 1: HPT attended the VA Center for Women Veterans (CWV) National Partners and Stakeholder Meeting to discuss unique challenges that homeless women veteran face, 2024 VA homelessness goals, available resources, and organizational updates.

## **Legislative Bill Reviews:**

- H.R. X Setting the Table for Transition Act
  - This legislation would lower a family's income threshold for the purposes of determining SNAP eligibility by counting only the veteran's income for the family when determining eligibility.
