Division Operations

Meetings:

- June 4: Division Director met with Veterans Health Administration (VHA) Office of Health and Innovative Learning (OHIL) to discuss strengthening the collaborative relationship between VHA and Veterans Service Organizations.
- June 4: Division Director and Veterans Program Manager met with the Department of Minnesota Department Service Officers to discuss correction and update to proposed resolution on memorial benefits for veterans.

- June 3: The Health Policy Team (HPT) attended the Family, Caregivers, and Survivors Federal Advisory Meeting to learn about recommendations being made to the Secretary of the Department of Veterans Affairs (VA) regarding support services, eligibility, access to mental health services, and communication with providers about plans of care.
- June 4: HPT attended a meeting with Lindsay Livingston, Mathew Riley, Lori Murphey, and Melissa Tran from the VA Innovation team. This meeting discussed two new VA programs. Compassionate Contact Corps, a program designed to combat loneliness and the PERPARE program, a new perinatal program for veterans in the VA maternity care program.
- June 4: HPT attended a Veteran Service Organization (VSO) roundtable discussion on VA innovation programs hosted by Paralyzed Veterans of America.
- June 4 5: HPT Deputy Director of Health Policy (DDHP) attended the PACT Act EPMO Second Annual Offsite to discuss PACT Act innovations including the VA PACT Act Performance Dashboard and the creation of a Collective Veteran Authoritative Dataset (CVAD).
- June 5: HPT attended the Senate Committee hearing on Veterans Affairs (SVAC) Special Committee on Aging and Veterans' Affairs Committee: Heroes at Home: Improving Services for Veterans and their Caregivers which discussed challenges with caregiver programs/benefits, caregiver mental health services, and care for aging veterans at home and in the community.
- June 5: HPT attended a meeting with Vice Chairman Cohen regarding planning for the Albuquerque System Worth Saving (SWS) trip on June 24.
