Health Policy Team (HPT) Operations

Meetings:

- September 23-26: HPT conducted a System Worth Saving (SWS) site visit at the Fort Harrison Montana Department of Veterans Affairs (VA) Medical Center. A Town Hall was hosted at Legion Post 2 in Helena, Montana to hear veteran feedback on their VA healthcare. Additionally, the HPT met with VA leadership and staff to capture best practices and challenges.
- September 23: Deputy Director for Health Policy (DDHP) attended One Million Reasons event to celebrate to historic milestone of the VA's Million Veteran Program (MVP) reaching over a million participants. This has created the world's largest data set connected to healthcare.
- September 24: HPT met with Academy of Ophthalmology (AAO) to discuss the current status of the National Standards of Practice (NSP). The meeting highlighted AAOs concerns of allowing Optometrist to do laser surgery.
- September 24: Andrew (Emerging Therapies Roundtable)
- September 24: DDHP attended The Elizabeth Dole Foundation (EDF) Caregiver Convening. This annual event is the premier conference for those who support military and veteran caregivers in America. The event provided personal testimonies and highlighted current issues facing the Caregiver community.
- September 24-25: HPT hosted gold star families for their fly-in to Washington DC during gold star family remembrance week. These families visited lawmakers to advocate for four bills which The American Legion also supports through our legislative efforts.
- September 25: HPT attended the Joint EDF and Tragedy Assistance Program for Survivors ceremony honoring lawmakers and advocates who improve the VA Caregiver program through legislation.
- September 25: HPT attended the VSO Quarterly Stakeholder Meeting. The meeting provided an update on VHA Psychedelic-Assisted Therapy, The SSG Fox Suicide Prevention Grant, Social Prescribing, and the ability to transform care through human connection
- September 26: DDHP and Deputy Director for Benefits and Claims (DDBC) met with representatives of the Office of the Vice President Laura E. O'Neill and Tahina L.

Montoya to discuss VA&R programs and our top priorities and issues facing the veteran community.

Legislative Activities

HR. xx- Loved Ones Interment Act- To amend title 38, United States Code, to authorize the SECVA to furnish headstones and markers for certain veterans for whom urns were previously furnished when such veterans are interred with other eligible individuals and for other purposes. - Recommended Support

Approved a quote for National Commander on Ensuring Justice for Camp Lejune Victims Act: "On behalf of our 1.6 million dues-paying members, The American Legion is proud to support the Ensuring Justice for Camp Lejeune Victims Act of 2024. This bill enhances previous Camp Lejeune water legislation by expanding judicial jurisdiction to any of the five states of the U.S. Court of Appeals for the 4th Circuit — Maryland, Virginia, West Virginia, North Carolina and South Carolina — rather than just in North Carolina's federal courts. In addition, this bill codifies caps on attorney's fees for administrative claims and for lawsuits filed in court based on Department of Justice recommendations. We applaud Senator Tillis and Senator Blumenthal for their leadership in expanding court access and protecting our veterans and their families from predatory actors."
