### Health Policy Team (HPT) Operations

### **Meetings:**

- Oct 25: HPT attended the second Department of Defense Survivor Symposium. Topics Discussed included, DoD Tricare, VA remarriage penalties, and education and employment services for active duty surviving spouses.
- Oct 29 30: The Deputy Director for Health Policy (DDHP) was invited to participate in the 2024 VHA Innovation Experience (iEx). This year's iEx provided attendees with the opportunity to mingle with innovators, VA employees, veterans, industry leaders, and entrepreneurs. The American Legion was invited to participate in a 75-minute Breakout Session titled: Connection Café: Engaging Veteran Service Organizations (VSOs). The discussions were centered on increasing collaboration and information sharing with community partners, VA, and VSOs. Additionally, this year's iEx highlighted many promising interventions including:
  - <u>FastTrack PGx Results</u>: empowering timely tailored prescriptions and precision medicine
  - o Re-Engaging Veterans in Pain through Extended Reality (VIPER): Virtual Reality
  - o HIVES- Honeybee Initiative for Veteran's Empowerment and Support
- Oct 29: HPT attended the EHRM (Electronic Health Record Modernization) Quarterly Town Hall Briefing
  - EHRM rollout resumption is delayed to FY26 as VA and Oracle work to address system issues and ensure ready deployment without veteran harm.
- Oct 30: HPT Digitally attended Secretary McDonough's "State of the VA" Presentation, where the continued expansion of the PACT act was discussed, specifically inclusion of K2 veterans.
